BY THE KING. A PROCLAMATION

APPOINTING SATURDAY THE FIRST DAY OF JANUARY, ONE THOUSAND NINE HUNDRED AND FORTY-FOUR, A BANK HOLIDAY THROUGHOUT ENGLAND, WALES AND NORTHERN IRELAND FOR THE PURPOSES OF THE BANK HOLIDAYS ACT, 1871.

BANK HOLIDAYS ACT, 1871.

GEORGE R.I.

WHEREAS We consider it desirable, in the circumstances of the present emergency, that Saturday the first day of January one thousand nine hundred and forty-four, shall be kept as a close holiday in all banks in England, Wales and Northern Ireland and shall, as regards bills of exchange and promissory notes payable in England, Wales or Northern Ireland be deemed to be a bank holiday for all the purposes of the Bank Holidays Act, 1871:

NOW, THEREFORE, in exercise of the powers conferred by section four of the said Act, We do by this Our Royal Proclamation, by and with the advice of Our Privy Council, appoint the said first day of January to be observed as a bank holiday throughout England, Wales and Northern Ireland.

And We do declare that this Proclamation does not have the effect of making the said day a holiday

under, or for the purposes of, the Holidays Extension Act, 1875.

Given at Qur Court at Buckingham Palace, this seventeenth day of November, in the year of our Lord, one thousand nine hundred and forty-three and in the seventh year of Our Reign.
