ELECTION OF BELFAST HARBOUR COMMISSIONERS.

Order in Council dated the 21st March, 1944, made under section two and four of the Chartered and Other Bodies (Temporary Provisions) Act (Northern Ireland), 1940.

BY THE GOVERNOR IN THE PRIVY COUNCIL OF NORTHERN IRELAND.

# ABERCORN.

Whereas by the Belfast Harbour Commissioners (Postponement of Elections) Order (Northern Ireland), 1940 (hereinafter referred to as "the principal Order"), and by the Belfast Harbour Commissioners (Postponement of Elections) (No. 2) Order (Northern Ireland), 1942, and the Belfast Harbour Commissioners (Postponement of Elections) (No. 3) Order (Northern Ireland), 1943, (hereinafter referred to as "the amending Orders"), made under sections two and four of the Chartered and Other Bodies (Temporary Provisions) Act (Northern Ireland), 1940, provision was made for extending the term of office and postponing the election of Belfast Harbour Commissioners and for incidental and consequential matters, and directions were given, as appearing in the principal Order as varied by the amending Orders: Orders:

And whereas application has been made on behalf of the said Commissioners praying that the Governor of Northern Ireland may be pleased to make a further Order in Council varying the Orders made with respect to them under the said

Now, therefore, I, James Albert Edward, Duke of Abercorn, Knight of the Most Noble Order of the Garter, Knight of the Most Illustrious Order of Saint Patrick Covernos of Northern Leibard of the Garter, Knight of the Most Indistrious Order of Saint Patrick, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland, in exercise of the powers conferred upon me by sections two and four of the Chartered and Other Bodies (Temporary Provincional Act (Northern Ireland) 1000 and of all visions) Act (Northern Ireland), 1940, and of all

other powers enabling me in that behalf, do hereby

order as follows:—

1. The elections of one-third of the Commissioners which would apart from the principal Order and the amending Orders, have been held under the Harbour Acts (as in the principal Order defined), in the years nineteen hundred and fortyone, nineteen hundred and forty-two, and nineteen hundred and forty-three, shall be further post-poned, respectively, until the years nineteen hundred and forty-six, nineteen hundred and fortyseven and nineteen hundred and forty-eight, and the term of office of Commissioners holding office at the date of this Order shall be further extended accordingly.

The principal Order, as varied by the amending Orders, shall have effect as if, for the reference in pargraph (1) of Article 2 thereof to the year nineteen hundred and forty-five, there were substituted a reference to the year nineteen hundred and forty-six.

3. This Order may be cited as the Belfast Harbour Commissioners (Postponement of Elections) (No. 4) Order (Northern Ireland), 1944, and shall be construed as one with the principal Order,

CIVIL AUTHORITIES (SPECIAL POWERS) ACTS (NORTHERN IRELAND), 1922 to 1943.

Whereas there is reason to believe that assemblies of persons have been or are about to be convened for the purpose of holding meetings or processions in Northern Ireland to commemorate the rebellion of Easter Weck, 1916, or for the promotion of the objects of the Irish Republican Army or any other unlawful Association.

And whereas there is reason to apprehend that such assemblies of persons and the holding of such

such assemblies of persons and the holding of such meetings or processions will give rise to grave disorder or conduce to a breach of the peace or promote disaffection and thereby cause undue demands to be made upon the Police Force:

Now, therefore, I, the Right Honourable William Lowry, K.C., M.P., Minister of Home Affairs for Northern Ireland being the Civil Authority under the Civil Authorities (Special Powers) Acts (Northern Ireland), 1922 to 1943, do hereby in accordance with the provisions of Regulation 4 of the Regulations made under the authority of the said Acts, prohibit the holding of any such assemblies, meetings or processions in Northern assemblies, meetings or processions in Northern Ireland during the period from the 6th day of April, 1944, to the 12th day of April, 1944, both dates inclusive.
