#### EXPLOSIVES ACT, 1875.

In virtue of the power conferred on me by Section 53 of the Explosives Act, 1875, and of every other power enabling me in this behalf, I, the Right Honourable William Lowry, K.C., M.P., being the Minister of Home Affairs for Northern Ireland, hereby appoint Sergeant Thomas Twamley Somerset (No. 1842), of the Royal Ulster Constabu-lary, as an Inspector for Northern Ireland under the said Act, and do hereby direct him to exercise only such powers and to perform such duties under the said Act as I shall from time to time assign to him. to him.
