EMERGENCY POWERS (DEFENCE) SHOPS: EMERGENCY CLOSING.

Order, dated 23rd September 1944, made by the Ministry of Home Affairs under Regulation 60AC of the Defence (General) Regulations. 1939.

Whereas the Ministry of Home Affairs for Northern Ireland (hereinafter referred to as "the Ministry") has by an Order of the Governor of Northern Ireland made under paragraph (9B) of Regulation 102 of the Defence (General) Regulations, 1939, been specified as the department of the Government of Northern Ireland by which the powers conferred by paragraph (9) of Regulation 60AC of the said Regulations should be exercised:

And whereas the Ministry in pursuance of the powers so conferred upon it made an Order entitled the Shops (Emergency Closing) (Belfast) (Northern Ireland) Order, 1944, applying the said Regulation 60AC to the County, Borough of Belfast subject to certain adaptations and variations specified therein:

And whereas it is expedient to extend the operation of the last mentioned Order in manner hereinafter appearing.

Now, therefore, the Ministry in pursuance of the powers so conferred upon it and of all other powers enabling it in that behalf hereby makes the following Order:-

- 1. Paragraph 5 of the Shops (Emergency Closing) (Belfast) (Northern Ireland) Order, 1944, shall have effect as if for the reference therein to the 30th day of September, 1944, there was substituted a reference to the 31st day of March, 1945.
- 2. This Order may be cited as the Shops (Emergency Closing) (Belfast) (Northern Ireland) (No. 2) Order, 1944.

#### PUBLIC HEALTH (IMPORTED FOOD) REGULATIONS (NORTHERN IRELAND), 1937.


The Ministry of Health and Local Government gives notice, in pursuance of the above-named Regulations, that it hereby recognises the Official Certificates of which particulars are given in the Schedule hereto as showing (a) that meat from which the meat product to which they relate was prepared, was derived from animals inspected ante and post mortem and passed in accordance with criteria satisfactory to the Ministry; and (b) that all necessary precautions for the prevention of danger to public health were taken in the dressing or preparing and packing of the meat or meat product.

Where the Certificate is in the form of a label, the recognition will apply only if the label is securely affixed to the meat or the package containing the meat product, and if the label has not in any other circumstances or on any other occasion been used as an Official Certificate; and where the Certificate is in the form of a stamp, the recognition will apply only if the stamp is clearly impressed on the meat or the container, as the case may be.

#### CHEDULE

#### DOMINION OF NEW ZEALAND.

For the following meat products, namely, canned meats, animal casings and edible fats, a label or stamp bearing a design in either of the forms set out below and not less than those forms in size :--



The Certificate will be completed by the insertion of the number of the establishment. The label and stamp hereby recognised are alternative to the Certificates reproduced in Part VIII of the Schedule to the Notice published in the Belfast Gazette of the 8th April, 1938, so far as the latter Certificates relate to the meat products as the latter Certificates relate to the meat products referred to in this Schedule.
