CIVIL AUTHORITIES (SPECIAL POWERS) ACTS (NORTHERN IRELAND), 1922 TO 1943.

WHEREAS by Regulation 26 of the Regulations to which the Civil Authorities (Special Powers) Acts (Northern Ireland), 1922 to 1943, apply (being a Regulation made by the Minister of Home Affairs-and having effect and to be enforced in like manner as Regulations contained in the Schedule to the Civil Authorities (Special Powers) Act (Northern Ireland), 1922, it is provided that if it appears to the Minister of Home Affairs that the publication or continued publication of any newspaper, periodical, book, circular, or other printed matter is prejudicial to or likely to be prejudicial to the preservation of the peace and the maintenance of order in Northern Ireland, the said Minister may by order prohibit for any specified period the publication of any such WHEREAS by Regulation 26 of the Regulations to for any specified period the publication of any such newspaper, periodical, book, circular, or other printed matter :

printed matter: AND WHEREAS by the said Regulation 26 it is pro-vided that if any person shall, within such specified period, print, publish, circulate or distribute or be in any way concerned in the printing, publication, circulation or distribution of any newspaper, peri-odical, book, circular or other printed matter, the publication of which has been prohibited under the said Regulation 26, he shall be guilty of an offence against the Regulations to which the aforesaid Acts apply: apply :

AND WHEREAS it appears to me, the said Minister, that the publication or continued publication of the book and newspapers hereafter in this order speci-fied is prejudicial to or likely to be prejudicial to

hed is prejudicial to or inkely to be prejudicial to the preservation of the peace and the maintenance of order in Northern Ireland: Now, THEREFORE, I, the Right Honourable Edmond Warnock, K.C., M.P., Minister of Home Affairs for Northern Ireland, in exercise of the powers vested in me by the Civil Authorities (Special Powers) Acts

- and the newspapers entitled :--"An Phoblacht" or "The Republic" or "The Loyalist" or "The Republican Press," "The Irish World and American Industrial Liberator,"

- Liberator," "Fianna," "Republican Congress," "An Siol" or "The Seed," "Saoirse Eireann Wolfe Tone Weekly," "Irish. Freedom," "The Sentry," "Red Hand," and "The Critic," nder these titles or under any other

under these titles, or under any other title or description whatever, shall be and is hereby pro-hibited in Northern Ireland as from the 1st day of January, 1945, until the 31st day of December, 1945.
