DIPLOMATIC PRIVILEGES (EXTENSION) ACT, 1944.

WAGES COUNCIL ACT (NORTHERN IRELAND), 1945.

RETAIL BESPOKE TAILORING WAGES COUNCIL (NORTHERN IRELAND).

The Retail Bespoke Tailoring Wages Council (Northern Ireland) hereby gives notice of its intention to submit to the Ministry of Labour proposals for (1) the revocation of Order N.I.T.R.B. (23) dated 8th September, 1926, as amended by Orders N.I.T.R.B. (46) dated 18th May, 1943, N.I.T.R.B. (48) dated 31st August, 1943, N.I.T.R.B. (52) dated 6th October, 1944, and N.I.T.R.B.
