Elections: Postponement of publication of Register in respect of the County of Londonderry.

Order, dated 7th August, 1946, made by the Ministry of Home Affairs under Section Four-teen of the Elections and Franchise Act (Northern Ireland), 1946.

WHEREAS it is provided by sub-section (3) of Section Thirty of the Elections and Franchise Act (Northern Ireland), 1946 (hereinafter called "the Act of 1946") that the Register of Electors in respect of each administrative county and of the County Borough of Belfast shall be published and come into force on the First day of July, Nineteen Hundred and Forty-six: Hundred and Forty-six:

AND WHEREAS the Ministry of Home Affairs for Northern Ireland: (hereinfter called "the Ministry") made an Order under the provisions of Section Fourteen of the Act of 1946 entitled the Electoral Register (Postponement of Publication) Order, 1946, postponing the publication of the said Registers until the Fifteenth day of August, Nine-teen Hundred and Forty-six:

AND WHEREAS it appears to the Ministry that as respects the Administrative County of London-derry, the time allowed for the publication of the Register is insufficient and that it should be further postponed :

NOW, THEREFORE, the Ministry, in exercise of the powers conferred upon it by Section Fourteen of the Act of 1946, and of every other power in that behalf thereunto enabling, the Ministry DOTH HEREBY ORDER that the date of publication of the Register for the Administrative County of Londonderry be postponed from the said Fifteenth day of August, Nineteen Hundred and Forty-six, until the Eleventh day of September, Nineteen Hundred and Forty-six.

This Order may be cited as the County of Lon-donderry Electoral Register (Postponement of Pub-lication) Order (Northern Ireland), 1946.

Postponement of Local Government Elections; County and County Borough of Londonderry

Order, dated 8th August, Nineteen Hundred and Forty-six, made by the Ministry of Home Affairs under Section Forty-seven of the Elections and Franchise Act (Northern Ireland), 1946.

Franchise Act (Northern Ireland), 1946. WHEREAS it is provided by Section Forty-seven of the Elections and Franchise Act (Northern Ire-land), 1946 (hereinafter referred to as "the Act of 1946") that where an Order under Section Fourteen of the Act of 1946 postponing the date of publica-tion of a Register is in force, the Ministry of Home Affairs for Northern Ireland (hereinafter referred to as "the Ministry") may by a further Order direct that for any date fixed under Section Forty-five or Forty-six of the Act of 1946 for nomination or election of candidates in Local Government Elections, there shall be substituted such other date (not being later than three months after the date so fixed) as may be specified in the Order; and any such Order may contain such consequential provisions as may be necessary for giving effect to the said Section : Section :

NOW, THEREFORE, the Ministry, in exercise of the powers conferred upon it by Section Forty-seven of the Act of 1946 and of every other power in that behalf thereunto enabling the Ministry, DOTH HEREBY ORDER as follows:-


