(NORTHERN IRELAND), 1945.
DRESSMAKING AND WOMEN'S LIGHT
CLOTHING WAGES COUNCIL
(NORTHERN IRELAND).

The Dressmaking and Women's Light Clothing Wages Council (Northern Ireland) hereby gives notice of its intention to submit to the Ministry of Labour and National Insurance proposals for the revocation of Order N.I.W.D. (44) dated 27th July, 1944, and for the fixing of specified statutory minimum remuneration in substitution for the minimum rates of wages at present in operation.
