#### BY THE GOVERNOR OF NORTHERN IRELAND.

## GRANVILLE.

WHEREAS by sub-section (1) of Section 30 of the Unemployment Assistance Act (Northern Ireland), 1934, as amended by sub-section (1) of Section 10 of the Old Age and Widows' Pensions Act (Northern Ireland), 1940, it is provided that there shall be constituted a Board to be called the Assistance Board for Northern Ireland.

And Whereas by the Fourth Schedule to the said first mentioned Act, it is further provided that the said Board shall consist of a Chairman and not less than one nor more than four other members appointed by the Governor of Northern Ireland and that every member of the Board shall hold and vacate office in accordance with the terms of his appointment.

And Whereas the term of office of the several

members of the Board as now constituted will terminate on 30th June, 1947.

Now, Therefore, I, William Spencer, Earl Granville, Knight Commander of the Royal Victorian Order, Companion of the Most Honourable Order of the Bath, Companion of the Distinguished Service Order, Vice-Admiral, Governor of Northern Ireland, do hereby, in pursuance of the aforesaid enactments, appoint The Right Honourable John Fawcett Gordon to be Chairman of the said Board from 1st July, 1947, until 30th June, 1948, and Mrs. Martha Ringland Collis, and Robert Heggarty Coulter, Esq., to be members of the said Board from 1st July, 1947, until 30th June, 1948.

Given at Government House, Hillsborough, this ninth day of June, in the year one thousand nine hundred and forty-seven.

WAGES COUNCILS ACT (NORTHERN IRELAND), 1945.

BRUSH AND BROOM WAGES COUNCIL (NORTHERN IRELAND).

The Brush and Broom Wages Council (Northern The Brush and Broom Wages Council (Northern Ireland) hereby gives notice of its intention to submit to the Ministry of Labour and National Insurance proposals for amending the Brush and Broom Wages Council (Northern Ireland) Wages Regulation Order, 1946, (S.R. & O. 1946, No. 195), dated 17th September, 1946, by providing for the continuing in effect of statutory minimum remuneration after the termination of the cost of living index figure based on the average percentage increase since July, 1914, in retail prices (all items) in the United Kingdom.
