DANGEROUS DRUGS ACTS (NORTHERN IRELAND), 1920 TO 1932

SUSPENSION OF WITHDRAWAL OF AUTHORITY FROM DUNCAN BLACK, M.B., B.Ch.

WHEREAS in pursuance of the powers conferred on the Minister of Home Affairs by the Dangerous Drugs Regulations, 1938, the Authority granted by the said Regulations to duly qualified medical practitioners to be in possession of and to supply the drugs or preparations to which these Regulations apply was, by Notice published in the "Belfast Gazette" on the 18th March, 1949, withdrawn from Duncan Black, M.B., B.Ch., of 44 Westland Bungalows, Westland Road, Belfast.

And whereas at the same time a Direction was given by the Minister of Home Affairs that it should not be lawful for the said Duncan Black to give prescriptions for the purposes of the said Regulations:

Now, Therefore, I, the Right Honourable Edmond Warnock, K.C., Minister of Home Affairs for Northern Ireland, do hereby suspend, until further Order, the operation of the said Notice of Withdrawal and of the said Direction regarding prescriptions.
