ROADS ACT (NORTHERN IRELAND) 1948

The Ministry of Commerce hereby gives notice in accordance with the provisions of the First Schedule to the Roads Act (Northern Ireland) 1948 that it proposes to make an Order under Sections 1 and 3 of that Act, the general effect of which will be as follows:

 On the date of the coming-into-force of the Order the road proposed to be constructed by the Ministry known as "the North Approach Road" will become a trunk road. The route of the North Approach Road is from the Belfast-Carrickfergus road (A.2) at Whitehouse near its junction with the Whitewell Road in a general north-westerly direction, passing under the Belfast-Antrim Road (A.6) at Whitewell and to the southwest of Glengormley to the Belfast-Antrim Road at its junction with the Class III road C.30 and thence in a general northerly direction to the Glengormley-Larne Road (A.8) at its junction with the Glengormley-Ballyclare Road (B.56).

- (2) Those stretches of the Belfast-Coleraine-Londonderry and the Belfast-Larne trunk roads between their termination in Belfast and their junctions with the North Approach Road will cease to be trunk roads on the first day of April next after the Ministry has declared the North Approach Road open for the purposes of through traffic.
- (3) The Ministry will be authorised:
 - (a) to construct a bridge carrying the North North Approach Road over the Belfast-Carrickfergus Road and bridges carrying the Glengormley-Hightown Road and the unclassified road leading from Carnmoney to Ballycraigy over the North Approach Road;
 - (b) to stop up entirely the junctions between the North Approach Road and Longlands Road and to construct a new road between Longlands Road and the Whitewell Road;
 - (c) to stop up entirely the junction between the North Approach Road and the Whitewell Road and to construct a new road between the Whitewell Road and the Belfast-Antrim road;
 - (d) to stop up entirely the ⁶ junction between the North Approach Road and the Glengormley-Mallusk Road (B.85) on the west side and to construct a new road between the latter road and the Glengormley-Hightown Road.
 - (e) to stop up entirely the junction between the North Approach Road and the Glen-

gormley-Mallusk Road (B.95) on the east side and to construct a new road between the latter road and the unclassified road leading on to the Belfast-Antrim Road at Mossgrove;

(f) to stop up entirely the junction between the North Approach Road and the Class III road C.30 on the north-east side and to construct a new road between the latter road and the Belfast-Antrim Road.

The route of the North Approach Road and the details of the bridges and new roads it is proposed to construct and the junctions it is proposed to stop up are delineated on a map, a copy of which, together with a copy of the draft Order, may be inspected by any person free of charge at all reason-able hours during a period of forty days from 20th day of January, 1950, at any of the undermentioned offices :

In Part II of the said Third Schedule, after the item relating to "Arsenical substances," there shall be inserted the word "Dinitrocresols"; after the item relating to "Phenols" there shall be inserted the following item :-

"Phosphorus compounds, the following :---Bis-dimethylaminophosphonous anhydride, Diethyl-paranitrophenyl thiophosphate, Hexaethyl tetraphosphate, Tetraethyl pyrophosphate.

In accordance with the provisions of the said sub-Section (3) on the expiration of one month from the date of this publication the said Third Schedule shall have effect, subject to the inclusion in the said Part I thereof of the substances specified in the above-mentioned resolutions.
