EXPLOSIVES ACT, 1875

In virtue of the power conferred on me by Section 53 of the Explosives Act, 1875, and of every other power enabling me in this behalf, I, the Right Honourable Brian Maginess, K.C., M.P., being the Minister of Home Affairs for Northern Ireland, hereby appoint Sergeant John Hammond (No. 5671), of the Royal Ulster Constabulary, as an Inspector for Northern Ireland under the said Act and do hereby direct him to exercise only such powers and to perform such duties under the said Act as I shall from time to time assign to him.

GENERAL PERMISSION

Granted by the Treasury for the Purposes of Section 22(1)(d) of the Exchange Control Act, 1947(a)
