#### THE STATUTE LAW COMMITTEE FOR NORTHERN IRELAND

### MINISTRY OF HOME AFFAIRS FOR NORTHERN IRELAND

Explosives Act, 1875

WHEREAS Sergeant James Albert Greene (No. 2051) of the Royal Ulster Constabulary was, on the 15th November, 1945, appointed to be an Inspector for Northern Ireland under the Explosives Act, 1875;

AND WHEREAS the said Sergeant James Albert Greene is no longer available for the duties of Inspector;

NOW I, the Right Honourable Brian Maginess, K.C., M.P., being the Minister of Home Affairs for

Northern Ireland, in virtue of the power conferred on me by Section 53 of the said Act and of every other power enabling me in this behalf, do hereby order that the said Sergeant James Albert Greene shall from this day cease to exercise the powers and perform the duties of an Inspector under the said Act.

#### **EXPLOSIVES ACT. 1875**

WILD BIRDS: SALE FOR CONSUMPTION

Order dated 8th August, 1951, made by the Minister of Home Affairs under section 7 of the Wild Birds Protection Act (Northern Ireland), 1931, as amended by section 4 of the Wild Birds Protection Act (Northern Ireland), 1950.

WHEREAS it is provided by sub-section (1) of section 7 of the Wild Birds Protection Act (Nor-
