THE MINISTRY OF HOME AFFAIRS FOR NORTHERN IRELAND.

HOUSING ACT (NORTHERN IRELAND), 1923.

RURAL DISTRICT OF DUNGANNON.

WHEREAS the Ministry of Home Affairs for Northern Ireland is satisfied that there is an urgent need for Houses in the area adjoining the industrial centre of Coalisland situate in the Rural District of Dungannon in the Administrative County of Tyrone, and that proper housing accommodation for the working classes cannot be secured in such area except by the making of grants under the provisions of section 1 of the Housing Act (Northern Ireland), 1923, in respect of houses erected in the area:

And whereas the said area is defined in the schedule hereunto annexed and is not within one mile and a half from the boundary of the area of a local authority within the meaning of Section 6 of the aforesaid Act.

Now therefore the Ministry of Home Affairs for Northern Ireland in exercise of the powers vested in it by Sub-section 8 of Section 1 of the Housing Act (Northern Ireland) 1923, and after consultation with the Ministry of Finance for Northern Ireland, by this Order hereby extends subject to the proviso (b) cortained in the said sub-section (8) the provisions of sub-sections 1 to 7 inclusive of Section 1 of the said Act to the erection of houses in the area defined in the Schedule to this Order annexed. And the Ministry hereby determines that the grant payable in respect of each house so constructed shall be at the rate of sixty pounds.

The German Reparation (Recovery) No. 4 Order, 1924, dated September 8, 1924, made by the Board of Trade under the German Reparation (Recovery) Act, 1921 (11 & 12 Geo. 5, c. 5).

The Board of Trade, in pursuance of the powers conferred upon them by Section 5 of the German Reparation (Recovery) Act, 1921, and of all other powers enabling them in that behalf, upon the recommendation of a Committee constituted under Section 5 of the said Act hereby make the following Order:

1. This Order may be cited as " The German Reparation (Recovery) No. 4 Order, 1924."

2. Any article of the following description shall be exempt from the provisions of the said Act, that is to say, any article imported into Great Britain or Northern Ireland on or after the 9th day of September, 1924, in respect of which it is proved to the satisfaction of the Commissioners of Customs and Excise that-

- (a) the proportion of the value of the said article payable under the said Act to the said Commissioners does not exceed 10s., and
- (b) the said article is not included in the same consignment or order with other goods of such value that the sum payable to the said Commissioners under the said Act in respect of all goods so included exceeds 10s.

3. The German Reparation (Recovery) No. 2 Order, 1924, is hereby revoked so far as it relates to goods imported on or after the 9th day of September, 1924.
