##### ROPE, TWINE AND NET WAGES COUNCIL (NORTHERN IRELAND)

#### WILD BIRDS PROTECTION ACTS (NORTHERN IRELAND), 1931 AND 1950

In pursuance of Section 16(6) of the Wild Birds Protection Act (Northern Ireland), 1931, notice is hereby given that the Minister of Home Affairs proposes to make Orders under section seven of the Wild Birds Protection Act (Northern Ireland), 1931, as amended by section four of the Wild Birds Protection Act (Northern Ireland), 1950 (1) giving complete protection for a further period of three years as from the 8th August next to Barnacle and Brent Geese; and (2) making it unlawful, for a further period of three years from the same date, for any person to sell, or to have in his possession for the purpose of sale, for consumption in Northern Ireland or elsewhere by human beings or animals, any bird.

"Bird" for the purpose of the Order shall mean any wild bird or wild fowl, except grouse, pheasant, partridge, heath or moor game, black game, snipe and woodcock.

Any person objecting to these proposals should communicate with the Ministry of Home Affairs, Stormont, within 14 days of the date of publication of this notice.

#### GAME PRESERVATION ACT (NORTHERN IRELAND), 1928, AND GAME LAW AMENDMENT ACT (NORTHERN IRELAND), 1951

In pursuance of Section 7F of the Game Preservation Act (Northern Ireland), 1928, as inserted by Section 3 of the Game Law Amendment Act (Northern Ireland), 1951, notice is hereby given that the Minister of Home Affairs proposes to make Orders under Section 7 of the Game Preservation Act (Northern Ireland), 1928, as amended by the said Act of 1951:

- (1) varying the period of the close season for snipe so that it ends on the thirty-first day of August and not, as at present, on the thirtieth day of September;
- (2) giving complete protection for a period of one year from the first day of October next to partridge.

#### RATES OF INTEREST ON LOANS ADVANCED FROM AGRICULTURAL LOANS FUND

##### THE IRVINE PILOTAGE (AMENDMENT) ORDER, 1954

The Minister of Transport and Civil Aviation hereby gives notice that he has made under section 7 of the Pilotage Act, 1913, the Irvine Pilotage (Amendment) Order, 1954, in respect of the Irvine Pilotage District.

The Order amends the Irvine Pilotage Order, 1921, scheduled to the Pilotage Orders confirmation (No. 3) Act, 1921, by rearranging the Irvine Pilotage District and providing that pilotage shall cease to be compulsory within the District.
