DISTRIBUTION OF ROUMANIAN, HUNGARIAN AND BULGARIAN PROPERTY

Extension of the Periods in which Claims may BE MADE

The Administrators of Roumanian, Hungarian and Bulgarian Property announce that H.M. Treasury have extended to June 30, 1955, the period the Treasury ing applications to establish claims under the Treasury Directions.*

The periods originally prescribed ended on January 31 in the case of Roumania and on February 28 in the case of Hungary and Bulgaria.

GOVERNMENT OF NORTHERN IRELAND MINISTRY OF COMMERCE

Roads Act (Northern Ireland), 1948

The Ministry of Commerce hereby gives notice in accordance with the provisions of the First Schedule to the Roads Act (Northern Ireland), 1948, that it proposes to make an Order under Sections 1 and 3 of that Act, the general effect of which will be as follows:

(1) The road proposed to be constructed by the Ministry (which road is hereinafter referred to as "the new trunk road") shall become a trunk road on the date of the coming into force of the Order. The route of the new trunk road is from a point on the Belfast-Ballygawley-Londonderry Trunk Road (T.3) approximately 190 yards south-east of its junction with the third class road (C.161) to a point on the said trunk road adjacent to Birches Cross Roads, all in the townland of Ballynarry in the County of Armagh ;

(2) That section of the Belfast-Ballygawley-London-derry Trunk Road which extends from a point approximately 190 yards south-east of its junction with the third class road (C.161) to a point approximately 50 yards east of Birches Cross Roads shall cease to be a trunk road on the first day of April next after the date on which notice is given by the Ministry that the new trunk road

is opened for the purposes of through traffic. The Ministry will be authorised:

(a) to construct a length of new road connecting the new trunk road with the Belfast-Ballygawley-Londonderry Trunk Road;
(b) to construct a length of new road connecting the third class road (C.164) with the new

trunk road on its southern side at a point approximately 30 yards west of Birches Cross Roads:

Cross Roads;

(c) to stop up wholly the junction between the new trunk road and the Belfast-Ballygawley-Londonderry Trunk Road at a point approximately 120 yards south east of its junction with the third class road (C.161);

(d) to stop up wholly the junction between the new trunk road and Belfast-Ballygawley-Londonderry Trunk Road at a point approximately 30 yards east of Birches Cross Roads: Cross Roads:

to stop up wholly the junction between the third class road (C. 164) and the new trunk road on its southern side, at Birches Cross roads.

The route of the new trunk road and details of the new roads it is proposed to construct and the functions it is proposed to stop up, are delineated on

a map, a copy of which, together with a copy of the draft order, may be inspected by any person, free of charge, at all reasonable hours during a period of 40 days, from the 27th day of May, 1955, at either of the under-mentioned offices:—
