GOVERNMENT OF NORTHERN IRELAND MINISTRY OF COMMERCE

ROADS ACT (NORTHERN IRELAND), 1948

The Ministry of Commerce hereby gives notice in accordance with the provisions of the First Schedule to the Roads Act (Northern Ireland), 1948, that it proposes to make an Order under Sections 1 and 3 of that Act, the general effect of which will be as follows :-

- (1) The Ministry will be authorised to construct a new length of road in substitution for a length of the existing trunk road in the townland of Curr, between Ballygawley and Omagh, County Tyrone.
- (2) The aforementioned length of road (hereinafter referred to as "the new trunk road") will become a trunk road on the date of the coming into force of the Order. The route of the new trunk road is from a point on the Belfast-Ballygawley-Londonderry Trunk Road (T.3) at its junction with the third class road (C.682) in a general north-westerly direction to a point on the said trunk road approximately 930 yards north-west of the said junction.
- (3) That section of the Belfast-Ballygawley-London-derry Trunk Road which lies between a point approximately 183 yards north-west of its junction with the third class road (C.682) and a point on the said trunk road approximately 726 yards north-west of the said junction will cease to be a trunk road on the first day of April, next, after the date on which notice is given by the after the date on which notice is given by the Ministry that the new trunk road is opened for the purpose of through traffic.

 (4) The Ministry will also be authorised:

 (a) to construct lengths of new road connecting
- - the existing trunk road with the new trunk road at points approximately 246 yards and 620 yards north-west of the junction of the existing trunk road with the third class road (C.682);
 - (b) to stop up wholly the junctions which will exist between the new trunk road when con-

structed and the existing trunk road at points approximately 183 yards and 726 yards north-west of the junction of the existing trunk road with the third class road (C.682).

The route of the new trunk road and details of the new roads it is proposed to construct and the junctions it is proposed to stop up are delineated on a map, a copy of which, together with a copy of the draft order, may be inspected by any person, free of charge, at all reasonable hours during a period of 40 days from the 3rd day of November, 1955, at either of the undermentioned offices:—

 may use, the Commissioners' powers to borrow
 money on the security of the harbour revenues,
 and to confer upon the Commissioners power
 to re-borrow.
- 9. To provide that except to such extent as will be provided in the Bill all money borrowed under the authority of the Bill shall be applied in and towards the execution of the works and purposes authorised by the Bill and the existing Acts relating to Belfast Harbour, being purposes to which capital is properly applicable.

10. To apply certain of the provisions of the Belfast Harbour Act, 1893, with all necessary modifications to methods of borrowing money authorised by the Bill.

 To extend as regards the amount they may borrow the Commissioners' powers of temporary borrowing.

12. To increase to eighty years the maximum period within which the Commissioners are required to repay certain loans under the Belfast Harbour Act, 1893, the Belfast Harbour Act, 1918, the Belfast Harbour Act (Northern Ireland) 1931, and the Belfast Harbour Act (Northern Ireland) 1950 respectively.

13. To provide for the formation of and payments into a sinking fund or sinking funds by the Commissioners and for the application and investment of money paid into such fund or funds.

 To provide for the cesser of the Commissioners' obligations to form new sinking funds under the

existing Acts relating to Belfast Harbour and for the adjustment of existing sinking funds formed under those Acts.

15. To abolish the prohibition against discharging, within a period of five years from the date of the loan, a loan obtained by the issue of bonds under section 38 of the Belfast Harbour Act (Northern Ireland) 1931.
To authorise the Commissioners to carry to the

credit of their revenue account, out of money borrowed by them under the authority of the Bill, a sum or sums not exceeding the amount heretofore advanced out of revenue for certain

capital purposes to be specified in the Bill.

17. To increase the Commissioners' powers to charge the following rates and tolls:—
