NOTICE is hereby given that the Lord Mayor, Aldermen and Citizens of the City of Belfast (hereinafter respectfully referred to as "the Corporation" and "the City") intend to apply to Parliament in the ensuing Session for leave to bring in a Bill (hereinafter referred to as "the Bill") of which the following are the main objects:—

FLOOD PREVENTION WORKS

To enable the Corporation to make and maintain the following works within the City for the prevention of flooding and the improvement of the Blackstaff River, together with all such subsidiary or ancillary works as may be necessary or convenient, that is to say:—

In the City

Work No. 1

A culvert commencing in the townland of Malone Lower in the parish of Shankill at a point on the western boundary of Broadway 0.90 chains or thereabouts north-westward of the junction of Donegall Road and Broadway and terminating in the River Lagan (Extra Parochial) at a point 2.00 chains or thereabouts south-westward of the entrance to Botanic Bungalows.

In the Parish of Shankill in the City

Work No. 2

An alteration of the Blackstaff River partly in the said townland of Malone Lower and partly in the townland of Townparks consisting partly in a diversion or straightening and partly in a deepening and improvement of that river commencing at a point on the Blackstaff River 0.70 chains or thereabouts westward of the bridge carrying Broadway over the Blackstaff River and terminating at a point on the Blackstaff River at the western boundary of the bridge carrying Roden Street over Blackstaff River.

Work No. 3

A diversion and in part a deepening, widening and improvement of the Blackstaff River partly in the said townlands of Malone Lower and Ballymurphy and partly in the townlands of Ballydown-

fine and Ballygammon in the rural district of Belfast in the county of Antrim commencing in the said townland of Ballygammon immediately adjoining the junction of the City boundary with the boundaries of the said townlands of Ballydownfine and Ballygammon and terminating in the said townland of Malone Lower at the commencement of the said intended Work No. 3.

To authorise the diversion by means of the weir and sluices forming part of the intended Work No. 3 of the water flowing in the Blackstaff River and Clowney Water into the said intended culvert, Work No. 1, and to enact provisions as to the construction of such weir and the use of such sluices.

To empower the Corporation to fill in parts of the Blackstaff River and Clowney Water and to lay out and develop the parts so filled in and retain or dispose of the same.

To empower the Corporation to make and maintain in streets and lands shafts, manholes or other openings.

To empower the Corporation to alter or interfere with the bank, bed and foreshore of the River Lagan adjacent to the said intended Work No. 1 and to place and maintain, permanently or temporarily, cofferdams, piles, stagings and other works in the bank, bed and foreshore of the River Lagan.

To authorise the Corporation during the execution of any of the said works to close streets for public traffic and to underpin and strengthen houses and buildings.

To authorise the Corporation to deviate in the construction of the proposed Works both vertically and laterally from the lines or levels shown on the deposited plans and sections hereinafter referred to.

To apply to the construction and maintenance of the said intended works the provisions of Section 22 of the Belfast Improvement Act, 1884, empowering the Corporation to alter steps, areas, cellars, windows, watercourses, pipes and spouts and gas and water mains and pipes and telegraphic, telephonic, electrical or other pipes, tubes, wires and apparatus and to remove other obstructions.

To confirm the construction by the Corporation of the following work in the parish of Shankill in the City:—

An embankment partly in the said Townland of Ballymurphy and partly in the said Townland of Malone Lower commencing at a point 2 chains or thereabouts southward of St. James' Road and 5 chains or thereabouts westward of St. James' Crescent and terminating at a point 0.20 chains or thereabouts eastward of the eastern bank of the Blackstaff River and 19 chains or thereabouts southward of Donegall Road together with a sluice in the Blackstaff River.

To authorise the Corporation to discharge the surplus in any sewer above six times the average daily dry weather flow into the said intended culvert Work No. 1.

LANDS

To empower the Corporation to acquire by agreement or compulsorily lands and easements and rights in and over lands or waters in the City and in the townlands of Ballydownfine and Ballygammon in the rural district of Belfast in the County of Antrim for the purposes of the said intended works for any other purposes of the Bill or of obtaining access thereto or for the purposes of development or of any of the undertakings, powers or duties of the Corporation, or for the benefit, improvement or development of the City.

To authorise the Corporation to fill in, level, lay out and develop lands acquired by them under the powers of the intended Act and to retain and use or dispose of the same.

To authorise the Corporation to require the purification of industrial waste water discharging into surface water sewers on the lands so acquired and developed by them.

To empower the Corporation to acquire by agreement land in the City and to transfer the same to the Northern Ireland War Memorial Committee or

to assist the said Committee in the purchase of land in the City.

To authorise the Corporation to appropriate the subsoil of any street in which they may construct any of the said intended works.

To empower the Corporation to acquire easements only in certain cases and to enter on and take possession of lands without compliance with sections 84 to 90 of the Lands Clauses Consolidation Act, 1845, and to enact special provisions in lieu of Section 92 of the Lands Clauses Consolidation Act 1845 as to the acquisition by the Corporation in certain cases of parts only of properties and to authorise the Ministry of Health and Local Government for Northern Ireland to make orders vesting in the Corporation lands which they may be authorised to acquire compulsorily under the intended Act.

To incorporate with the Bill and to extend or apply, with or without modification, to the acquisition of lands, easements and rights thereunder certain provisions of the Belfast Improvement Act 1884, the Belfast Corporation Act (Northern Ireland) 1923 and the Belfast Corporation Act (Northern Ireland) 1924 relating to the correction of omissions, mis-statements and erroneous descriptions in the plans and book of reference deposited as hereinafter mentioned, the acquisition by the Corporation by agreement of additional lands and easements, the making of compensation by the Corporation in works or lands, the application of the provisions of the Housing of Working Classes Act, 1890, the extinction of private rights of way over lands acquired compulsorily, the retention and disposal of lands by the Corporation and the compensation to be paid in respect of recent improvements, alterations or buildings or recently created interests.

To authorise the Corporation to make by-laws (a) for regulating the use of lands acquired and laid out under the powers of the intended Act, and (b) for regulating or controlling the use of broadcasting or loudspeaking appliances and equipment.

To incorporate with the Bill and to extend or apply, with or without modification, to the exercise of the powers thereunder certain provisions of the Belfast Corporation Act (Northern Ireland) 1923 relating to arbitrations, inquiries by government departments, determination of compensation in certain cases, application of Section 264 of Public Health (Ireland) Act 1878, consent of Corporation to be in writing, damages and charges to be settled by court, recovery of demands, judges not disqualified and powers of intended Act to be cumulative.

To enact all necessary provisions for giving full effect to the purposes of the Bill including the making, confirmation and enforcement of by-laws and the holding of inquiries.

The Bill will or may enable the Corporation to carry the provisions of the Bill into effect with all or any of the powers of the Acts hereinbefore referred to and of the Public Health Local Government Sanitary and Municipal Corporations Acts with such modifications as may be contained in the Bill.

The Bill will, so far as is necessary for the purposes aforesaid, vary and extend or repeal, alter and consolidate the provisions or some of the provisions of, amongst others, the following local and personal Acts and Orders:—

The Belfast Local Acts, 1845 to 1950, the Acts hereinbefore mentioned, and any other Acts and provisional Orders or Orders in Council directly or indirectly relating to any of the aforesaid purposes, or to the Corporation, or to the City or any part thereof, or to any public body having jurisdiction for any purpose in or over any part or parts thereof and will or may incorporate by reference or in extenso any provisions deemed expedient of those respective Acts, subject to such amendments, alterations or modifications as may be contained in the Bill.

To incorporate and apply, with or without amendment or alteration or to vary or render inapplicable, all or any of the provisions of the following Acts or some of them, viz:—
