NOTICE is hereby given that it is intended to make an application to the Electricity Commissioners for Northern Ireland for a Special Order to authorize the use of land for the purpose of an Electricity Generating Station and the generating, sale and distribution of electrithe generating, sale and distribution of electri-city by Michael Joseph Loughran, of Bally-gawley, in the County of Tyrone, in the Town-lands of Ballygawley, Grange, Lisbeg and Richmond, in the said County of Tyrone, on the road in the said Townlands named in the Schedule hereto. Overhead electric lines have been placed, the erection of which authority has been granted by the Tyrone County Council as the said road is not repairable by the Local Authority.
