CONSTABULARY ACT (NORTHERN IRELAND), 1922.

WHEREAS by Section 4 (1) of the Constabulary Act (Northern Ireland), 1922, it is provided that, in any case in which an additional force of the Royal Ulster Constabulary is stationed in a county or county borough by direction of the Minister, one half of the cost of such additional force, to the extent to which that force exceeds the free quota and calculated at the prescribed rate and according to the prescribed method for each sergeant and constable in excess of the free quota, shall be payable by the council of such county or county borough out of such local rate, in such manner, and upon such conditions as may be prescribed:

Now therefore I, the Right Honourable Sir Richard Dawson Bates, Minister of Home Affairs for Northern Ireland, do hereby prescribe that:

I. For the purpose of calculating the cost of any additional force of the Royal Ulster Constabulary stationed in a county or county borough by direction of the Minister the rate for each sergeant and constable in excess of the free quota shall be taken to be the sum of £331 per annum (or the sum of eighteen shillings per diem) made up as follows:—

Such cost shall be calculated at said daily rate for any day or portion of a day during which each sergeant or constable constituting part of such additional force is stationed as aforesaid in any county or county borough.

II. The number of sergeants and constables stationed in any county or county borough in excess of the free quota shall be certified to the Minister of Home Affairs and to the council concerned by the county inspector of the county, or the commissioner of the county borough, as the case may be, or by an officer of the Royal Ulster Constabulary acting for such county inspector or commissioner, upon Form 14/2 in the schedule annexed hereto.

III. One half of the cost of the additional force calculated at the rate and according to the manner laid down above shall be payable out of the following rates by the council of such county or county borough:—

- In the case of the County Borough of Belfast, out of the Police Rate or General Purposes
- Rate, or partly out of each such rate, as the Council of the County Borough may decide.
- In the case of the County Borough of Londonderry, out of the General Improvement Rate.
- In the case of the other counties, out of the Poor Rate.

1V. A demand for payment in respect of an additional force shall be issued by the Ministry of Home Affairs to the council concerned—

- (a) as soon as may be after the withdrawal of the additional force; or
- (b) in any case where such additional force is stationed in a county or county borough and not withdrawn at the 31st March or the 30th September in any half year, as soon as may be after the 31st March or 30th September in such half year, as the case may be.

V. Payment shall be made by the council of the county or county borough concerned of the amount included in such demand, by cheque payable to the Ministry of Home Affairs, not later than seven days from the next finance meeting of the council of the county or the county borough concerned held after receipt of demand by such council, and in any case not later than three months from the date of demand.

This Order shall have effect, and shall be deemed always to have effect as from the 1st June, 1922.

MERCHANT SHIPPING. FEES.

The Merchant Shipping (Fees) Amendment Order, 1924, dated 15th December, 1924, Marchant Shipping Act, 1894, as amended by the Fees (Increase) Act, 1923.

1. In pursuance of the powers conferred on the Board of Trade by the Merchant Shipping Act, 1894 (57 & 58 Vict. c. 60), as amended by the Fees (Increase) Act, 1923 (13 Geo. 5. c. 4), and of any other power in that behalf, the Board hereby direct that the fees specified in Parts 4 and 13 of the Schedule to the Merchant Shipping (Fees) Order, 1924 (S.R..& O., 1924, No. 1056), shall be subject to the following reductions, viz.:—

- Part 4.—Fees for the measurement for tonnage.—A reduction of 33¹/₃ per cent.
- Part 13.--Fees for the engagement and discharge of seamen (except fishermen).--A reduction of 20 per cent.

2. This Order may be cited as the Merchant Shipping (Fees) Amendment Order, 1924, and shall take effect as from the 20th day of November, 1924.

THE MIDWIVES (IRELAND) ACT, 1918. THE JOINT NURSING AND MIDWIVES COUNCIL ACT (NORTHERN IRELAND), 1922.

WHEREAS by Order in Council dated the 19th day of December, 1921, the Lords of His Majesty's Most Honourable Privy Council, in exercise of the powers vested in the Privy Council by Section 5. of the Midwives (Ireland) Act, 1918, after taking into consideration a Representation of the General Medical Council, were pleased to approve the Rules (a copy of which is hereto annexed) made by the Central Midwives Board for Ireland under the said Section 5. of the said Act for a period of three years from the date of the said Order.

And whereas by virtue of the Government of Ireland Act, 1920, and an Order made thereunder, and the Joint Nursing and Midwives Council Act (Northern Ireland), 1922, the aforesaid powers of the Privy Council and the functions of the Central Midwives Board for Ireland have, as respects Northern Ireland, been transferred to the Minister of Home Affairs for Northern Ireland and to the Joint Nursing and Midwives Council for Northern Ireland respectively.

And whereas the Joint Nursing and Midwives Council for Northern Ireland deem it expedient that the said Rules should remain in operation for a further period of four months, and have applied to the Minister of Home Affairs for Northern Ireland to approve the said Rules for such further period.

the said Rules for such further period. Now, therefore, I, The Right Honourable Sir Richard Dawson Bates, the Minister of Home Affairs for Northern Ireland, in exercise of the powers vested in me by the above-mentioned Acts, and of all other powers in this behalf hereunto enabling me, having taken the said Rules, together with a Representation of the General Medical Council with respect thereto, into consideration, hereby approve the said Rules for a further period of four months from the 19th day of December, 1924, subject to the Provisions of the Government of Ireland Act, 1920, and to anything done under or in pursuance of that Act, and to the Provisions of the Joint Nursing and Midwives Council Act (Northern Ireland), 1922.
