#### BYE-LAWS

His Excellency the Governor of Northern Ireland by and with the advice of the Privy Council of Nor-thern Ireland has made an Order dated 18th October, 1957, approving of certain additions to and alterations or amendments in the Bye-Laws of 1955 of the Institute of Chartered Accountants in Ireland.

The additions, alterations or amendments are to have effect from the date when the scheme of in-tegration between the Institute of Chartered Accountants in Ireland and the Society of Incorporated Accountants dated the fifth day of Decemeber, 1956, becomes effective.
