SUMMARY JURISDICTION

BALLYMACILROY TRUNK ROAD IMPROVEMENT

PUBLIC HEALTH (IMPORTED FOOD) REGULATIONS (NORTHERN IRELAND), 1937 AND 1948

The Ministry of Health and Local Government gives notice, in pursuance of the above-named Regulations, that it hereby recognises the official certificate of which particulars are given in the schedule hereto as showing (a) that the meat to which it relates or the meat from which the meat product to which it relates was prepared was derived from animals inspected ante- and post-mortem and passed in accordance with criteria satisfactory to the Ministry and (b) that all necessary precautions for the prevention of danger to public health were taken in the dressing or preparing and packing of the meat or meat product.

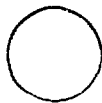
