QUEEN'S BENCH DIVISION—IN BANKRUPTCY

In the Matter of Thomas Robinson, of 22 Obin Street, Portadown, in the County of Armagh, Cattle Dealer, Bankrupt.

NOTICE is hereby given that a Meeting of the Creditors will be held in this Matter before the Court at the Royal Courts of Justice (Ulster) Belfast, on Thursday, the 5th day of January, 1960, at the

hour of 11 o'clock in the forenoon, for the Proof of Debts and for the purpose of considering the offer of composition which will then be made by the Bankrupt or his friends pursuant to the Statute.
