HERRING INDUSTRY SCHEME, 1951

NOTICE OF RULES

The Herring Industry Board hereby give notice that they have this day made Rules by virtue of the powers vested in them by the above Scheme having the effect of:

- 1. establishing from the first day of May, 1962:
 - (a) upset or minimum prices on first sales of herring by auction at various places for various uses;
 - (b) the terms and conditions under which buyers of fresh herring for certain uses may receive credit for herring found by them to be unsuitable for these uses and returned by them to the sellers;
 - (c) that certain buyers of fresh herring shall keep records of their purchases, furnish returns and shall allow inspection of these records by any person duly authorised by the Board; and
- prescribing from the first day of May, 1962, minimum standards of treatment in the processing by quick-freezing and cold-storing of herring and herring products.

TRUNK ROAD IMPROVEMENT AT BALLEE, CO. ANTRIM

The Ministry of Commerce hereby gives notice that it proposes to construct a length of new road
