TRUNK ROADS

PROPOSED NEW ROAD FROM SEDAN AVENUE TO DUBLIN ROAD, OMAGH

The Ministry of Commerce hereby gives notice that it proposes to construct a length of new trunk road from Sedan Avenue to Dublin Road in the Urban District of Omagh, Co. Tyrone. In accordance with the provisions of the First Schedule to the Roads Act (Northern Ireland), 1948, the Ministry also gives notice that it proposes to make an Order under Section 1 of the Act, the general effect of which will be as follows: which will be as follows:-

- The length of new road will become part of the Belfast-Ballygawley-Londonderry Trunk Road (T. 3) on the date of coming into force of the Order.
- 2. On the first day of April next after the afore-

mentioned length of new road is opened for the purpose of through traffic, (a) that length of the existing Trunk Road T.3 comprising Bridge Street, Bell's Bridge and part of Mountjoy Road will cease to form part of the trunk road system; and (b) that length of the existing Trunk Road T.3 comprising parts of High Street and Market Street (from Bridge Street to Dublin Road) will become part of the Omagh-Enniskillen Trunk Road (T.10).

The aforementioned works are delineated on a map, a copy of which, together with a copy of the draft Order, may be inspected by any person, free of charge, at all reasonable hours during the period from the 1st day of September, 1962, to the 10th day of October, 1962, at the following places:
