### THE BELFAST GAS UNDERTAKING

Application for a Special Order under the Gas Regulation Act, 1920, to purchase the Carrickfergus Gas Undertaking, to take by lease certain lands from the Belfast Harbour Commissioners and to extend the existing gas limits.

NOTICE is hereby given that application is intended to be made to the Ministry of Commerce for Northern Ireland (hereinafter referred to as "the Ministry") by the Lord Mayor Aldermen and Citizens of the City of Belfast acting by the Council (hereinafter called "the Corporation") whose address is City Hall, Belfast, for a Special Order (hereinafter referred to as "the Order") under and in pursuance of Section 10 of the Gas Regulation Act 1920, and the Statutes therein incorporated, for the following purposes (that is to say):

1. To purchase by agreement the Carrickfergus Gas undertaking including the lands on the South side of Irish Quarter West and North side of Irish Quarter South both in the Town of Carrickfergus Parish of St. Nicholas otherwise Carrickfergus and County of Antrim on which is erected the offices and works of the Carrickfergus Gas Company Limited containing 1 acre 12 perches 25 square/yards statute measure of thereabouts and measuring in front to Irish Quarter West 100 feet or thereabouts and in front to Irish Quarter South 76 feet or thereabouts and extending back from Irish Quarter West to Irish Quarter South in irregular lines on both sides thereof respectively and also the right in common with all other persons entitled thereto to the use of certain passages on the South side of Irish Quarter South in the Town of Carrickfergus aforesaid and to hold the said lands so acquired.

2. To acquire and take by lease for the term of ninety-nine years and six months from the 1st day of July, 1962, from the Belfast Harbour Commissioners the lands situate to the North East of the Ammunition Jetty in the Townlands of Ballymaghan—intake and Knocknagoney—intake in the Parish of Hollywood or extra parochial in the County of the City of Belfast containing 3 acres statute measure or thereabouts bounded on the North-East by the property of the Belfast Harbour Commissioners on the South-East by the property of Messrs. Short Brothers and Harland Limited, on the South-West by the property of the Belfast Harbour Commissioners, and on the North-West by Airport Road West together with necessary rights and easements.

3. To enter upon take and use for the purposes of their Gas Undertaking the said lands above described and to construct thereon all necessary works.

4. To extend the gas limits so as to comprise in addition to those limits:—

The Townlands of:

- (a) Ballystrudder, Cloghfin, Castletown (E.D. Islandmagee South), Castletown (E.D. Whitehead Urban) and Temple-Effin in the Parish of Islandmagee and County of Antrim.
- (b) Whitehead (E.D. Templecorran), Whitehead (E.D. Whitehead Urban), North West Ballycarry, South West Ballycarry, Redhall, Fort-hill, Bentra, Carnbrock and Knocknagulliah

in the Parish of Templecorran and County of Antrim.

- (c) Crossmary, Ballyhill, Dobbsland and Kilroot in the Parish of Kilroot and County of Antrim.
- (d) North East Division, Middle Division and West Division in the Parish of Carrickfergus or St. Nicholas and County of Antrim.
- (e) Ballyearl, Carntall, Straidnahanna, Lisnalinchy, Ballyhowne, Ballycalket and Kingsbog in the Parish of Ballylinny and County of Antrim.
- (f) Grange of Ballyrobert in the Parish of Templepatrick and County of Antrim.
- (g) Ballyloughan, Ballystockart, Ballyrussell and Ballymaglaff in the Parish of Comber and County of Down.

5. To charge all the costs charges and expenses of and incidental to the preparation and obtaining of the Order to the Corporation.

6. Generally to confer all such further and other powers upon the Corporation as may be deemed necessary or expedient for affecting the purposes aforesaid.

Any local or other public authority, company or person desiring to bring before the Ministry any objection to the draft Order may do so by registered letter addressed to the Secretary, Ministry of Commerce, Belfast, and despatched on or before the 31st day of December, 1962. Any such objection shall state:

- (a) the specific grounds of objection, and
- (b) the omissions, additions or modifications asked for.

A copy of the objection must be forwarded to the undersigned at the same time as it is sent to the Ministry.

Printed copies of the draft Order together with copies of Ordnance maps showing the situation of the lands proposed to be used for the manufacture or storage of gas or for the manufacture or conversion of residual products and the construction of works and also showing the boundaries of the proposed areas of supply and of the area in which the applicants are already authorised to supply gas, have been deposited for public inspection at the Office of the undersigned and with the Clerk of the Crown and Peace for the County of the City of Belfast and for the County of Antrim at his Office in County Court House, Crumlin Road, Belfast, and with the Clerk of the Crown and Peace for the County of Down at his Office in County Court House, Downpatrick.
