RULES OF THE SUPREME COURT, NORTHERN IRELAND

This Order delegates to the Registrar the power to transact the business and exercise the jurisdiction in the proceedings and matters specified in paragraph (1) of rule 1 of the Order (which includes matters in relation to execution). The Registrar is given power to adjourn any application to the Judge and there is provision in the Order for an appeal from the decision of the Registrar. The Order does not confer jurisdiction on a Registrar in a matter directly relating to the liberty of the subject.
