THE AGRICULTURAL PRODUCE (MEAT REGULATION AND PIG INDUSTRY) ACT (NORTHERN IRELAND) 1962

DEVELOPMENT LOANS ACT (NORTHERN IRELAND) 1945

Agricultural Development Loans

It has been decided that the rate of interest charged on Agnicultural Machinery Loans shall be increased by $\frac{3}{8}$ per cent as from Saturday, 14th March, 1964, from $8\frac{1}{4}$ per cent to $8\frac{5}{8}$ per cent and that the rate of interest charged on all other loans shall be increased by $\frac{3}{8}$ per cent as from the same date from $5\frac{3}{4}$ per cent to $6\frac{1}{8}$ per cent.
