IRISH SAILORS' AND SOLDIERS' LAND TRUST.

Irish Land (Provision for Sailors and Soldiers) Act, 1919.

Irish Land Trust (Powers) Act (Northern Ireland), 1923.

Administrative Provisions Act (Northern Ireland), 1925.

The Ministry of Finance for Northern Ireland and the Irish Sailors' and Soldiers' Land Trust in pursuance and by virtue of the powers vested in them or in either of them by Section 4 of the Irish Land (Provision for Sailors and Soldiers) Act, 1919, and Section 1 (5) of the Irish Land Trust (Powers) Act (Northern Ireland), 1923, as amended by Section 2 (1) of the Administrative Provisions (Northern Ireland) Act, 1925, and the several Acts incorporated therewith have made a Joint Order dated the 15th day of August, 1925, adapting the provisions of Section 2 of the Labourers (Ireland) Act, 1896, and Sections 21, 22 and 23 of the Labourers (Ireland) Act, 1906, for the purposes of the "Ministry" and of the "Trust."
