THE RESALE PRICES ACT 1964

OFFICE FURNITURE
and Related Classes of Goods

Notice is hereby given pursuant to Rule 8 of the Restrictive Practices Court (Resale Prices) Rules 1965 that on the twentieth day of August 1965 there was issued out of the Restrictive Practices Court in England and Wales a Notice of Reference applying to the following classes of goods:

- (1) Furniture for office use, and parts thereof, within headings 94.01 and 94.03 of the Convention for the Classification of Goods in Customs Tariffs (Cmnd. 1070) commonly known as and hereinafter called "The Brussels Nomenclature," but excluding the following:

 Fire-resisting files, cabinets and trolleys designed for the protection of documents and constructed with an outer casting enclosing insulating and-or fire-resisting material, and parts thereof; stands and pedestals designed for safes or for fire-resisting files or cabinets; security cupboards, with body and doors constructed of base metal of a thickness of 3/16 inch or more;
- (2) Filing cabinets, racks, sorting boxes, paper trays, paper rests and similar office equipment—of base metal, not designed to stand on the floor, but excluding document trays designed as fittings for safes or for fireresisting files, cabinets or trolleys—within heading 83.04 of the Brussels Nomenclature
- (3) Articles of wood for office use, the following:

 Book racks. invoice holders, shelves, trays
 and waste bins, wall tables;

- all within headings 44.27 or 44.28 of the Brussels Nomenclature
- (4) Wall tables of steel, within heading 73.40 of the Brussels Nomenclature
- (5) Base metal fittings, mountings, racks and the like the following:

Drawer runners, key control equipment and parts, including parts classified under any heading of the Brussels Nomenclature; all (unless the contrary is stated) within heading 83.02 of the Brussels Nomenclature.

Unless the Court otherwise directs these proceedings will take place in England.

And notice is hereby further given that

- (a) any supplier of goods of any of the classes to which the said Notice of Reference applies who supplies such goods under arrangements for maintaining minimum prices on resale but who has not duly given notice to the Registrar pursuant to section 6 (2) of the said Act in respect of such goods;
- (b) any retailer of goods of any of the classes to which the said Notice of Reference applies and
- (c) any trade association representing employees in the distributive trades

who wishes to be represented before the Court in the proceedings must notify the Registrar of Restrictive Trading Agreements at the address below in writing within 28 days hereof stating the nature of his interest and whether he supports or opposes the maintenance of minimum resale prices in respect of all or any of the goods to which the said Notice of Reference applies and giving the name of his solicitor (if any) and an address in the United Kingdom at which documents may be served upon him.
