PRICES AND INCOMES ACT, 1966

Reference to the National Board for Prices and Incomes

COSTS AND CHARGES IN THE RADIO AND TELEVISION RENTAL AND RELAY INDUSTRY

During recent years the charges made by companies providing radio and television rental and relay services have generally remained stable and in some cases have been reduced. Since the beginning of 1966, however, many of these companies have increased their charges and concern has been expressed at the increased costs now being faced by consumers.

It is recognised that the cost of providing these services has, for a variety of reasons, risen in recent times. In view, however, of the widespread impact on the public of increased charges in this field the First Secretary of State and the Minister of Tech-nology consider it desirable for costs and charges in this service industry to be examined by the National Board for Prices and Incomes.

Accordingly, in pursuance of their powers under Section 2(1) of the Prices and Incomes Act, 1966, the First Secretary of State and the Minister of Technology hereby refer to the National Board for Prices and Incomes for examination the question of costs and charges in the radio and television rental and relay industry.
