DEPARTMENT OF ECONOMIC AFFAIRS

PRICES AND INCOMES ACT 1966

Reference to the National Board for Prices and Incomes

PAYMENT BY RESULTS SYSTEMS

The National Board for Prices and Incomes drew attention in their Report on Productivity and Pay During the Period of Severe Restraint (Cmd. 3167) to the need for a study of payment by results systems of wage payment and their influence on productivity and earnings. These systems of payment include all kinds of piecework methods of payment, incentive bonuses added to basic pay in proportion to output and wider schemes relating earnings to the performance of a department or of the undertaking as a whole. The Government consider it desirable that the National Board for Prices and Incomes should examine examples of the practical application of the main types of schemes with a view to determining how far they further the interests of the undertakings concerned and of their employees and the objectives of the productivity, prices and incomes policy.

Accordingly, in pursuance of their powers under Section 2(1) of the Prices and Incomes Act 1966, the First Secretary of State and the Minister of Labour hereby refer to the National Board for Prices and Incomes for examination the question of payment by results systems.

JOB EVALUATION SCHEMES

A number of undertakings in the United Kingdom have introduced job evaluation schemes on a company or plant basis for determining the pay of their operatives and in some cases of their staffs. The Government consider it desirable that the National Board for Prices and Incomes should examine examples of the practical application of the main types of such schemes with a view to determining how far they assist in the development of wage and salary structures which promote the interests of the undertakings concerned and of their employees and further the objectives of the productivity, prices and incomes policy.

Accordingly, in pursuance of their powers under Section 2(1) of the Prices and Incomes Act 1966, the First Secretary of State and the Minister of Labour hereby refer to the National Board for Prices and Incomes for examination the question of job evaluation schemes.
