#### PAY AND CONDITIONS OF MERCHANT NAVY OFFICERS

On 26th April, 1967, in pursuance of their powers under section 2(1) of the Prices and Incomes Act, 1966, the First Secretary of State and the Minister of Labour referred the question of the pay and conditions of Merchant Navy Officers to the National Board for Prices and Incomes for examination.

### MINISTRY OF AGRICULTURE

Notice is hereby given that the Ministry of Agriculture in exercise of the powers conferred on it by section 6 of the Agriculture Act (Northern Ireland) 1949, made on the 24th May, 1967, the Agricultural Development (Amendment) Scheme 1967, Statutory Rule and Order No. 121. This Scheme amends the Agricultural Development Scheme 1961 in order to permit an additional grant of one-sixth to be paid for certain farm improvement works which qualify for a grant of one-quarter under the Agriculture Act 1967.

### MINISTRY OF HEALTH AND SOCIAL SERVICES

#### FACTORIES ACT (NORTHERN IRELAND) 1965

Notice is hereby given that on the 30th May 1967, the Ministry of Health and Social Services for Northern Ireland in pursuance of the powers conferred by Section 26(4) of the Factories Act (Northern Ireland) 1965, made an Order entitled the Factories (Exemption of Hoists) Order (Northern Ireland) 1967 which came into operation on 31st May 1967.

This Order exempts certain classes or descriptions of hoists and hoistways from some of the requirements of sections 23, 24 and 26 of the Factories Act (Northern Ireland) 1965. It replaces the Factories (Exemption of Hoists) Order (Northern Ireland) 1939 and the Factories (Exemption of Hoists) Amendment Order (Northern Ireland) 1947.

This Order amends the Construction (Lifting Operations) Certificates Order (Northern Ireland) 1963 by substituting a new form of certificate of tests and examinations of chains and other lifting gear made in pursuance of the Construction (Lifting Operations)
