Report of the National Board for Prices and Incomes

PAY OF ELECTRICITY SUPPLY WORKERS

On 11th August, 1967, in pursuance of their powers under Section 2(1) of the Prices and Incomes Act 1966, the First Secretary of State, the Minister of Labour and the Minister of Power referred for examination to the National Board for Prices and Incomes the scope for a further increase for electricity supply workers based on their contribution to increasing productivity and efficiency in the industry.

The Board has now made its report and in accordance with section 5(1) of the Prices and Incomes Act 1966 the Secretary of State of Economic Affairs, the Minister of Labour and the Minister of Power hereby give notice that the report was first published as Command Paper Number 3405 on 19th September, 1967.

If no such claim is received as aforesaid the said Order provides that the vehicle or container shall be deemed to be condemned as forfeited.
