### A PROCLAMATION

Appointing Monday, twentieth day of November, One Thousand Nine Hundred and Sixty Seven, a Bank Holiday throughout the United Kingdom for the purposes of the Bank Holidays Act 1871.

Whereas We consider it desirable that Monday, the twentieth day of November, 1967, shall be kept a close holiday in all banks in the United Kingdom and shall, as regards bills of exchange and promissory notes payable in the United Kingdom, be deemed to be a bank holiday for all the purposes of the Bank Holidays Act 1871:

Now, therefore, in exercise of the powers conferred by Section 4 of the said Act, We do, by this Our Royal Proclamation, by and with the advice of our Privy Council, appoint the said twentieth day of November to be observed as a bank holiday throughout the United Kingdom.

And we do declare that this Proclamation does not have the effect of making the said day a holiday under, or for the purposes of, the Holidays Extension Act 1875.

Given at Our Court at Windsor Castle, this Nineteenth day of November, in the year of Our Lord One Thousand Nine Hundred and Sixty Seven, and in the sixteenth year of Our Reign.

#### No. 15 Scheme, 1967

The Ministry of Commerce, in pursuance of section 5 of the Electricity (Supply) Act (Northern Ireland), 1948, as amended by section 16 of the Electricity (Supply) Act (Northern Ireland), 1967, has prepared a scheme for the provision of overhead lines and associated terminal equipment for that part of the interconnection between the co-ordinated electricity supply system of Northern Ireland and the electricity supply system of the Republic of Ireland which is to be constructed by the Electricity Board for Northern Ireland, as follows:

1. A new double circuit 275 kV overhead steel tower line from the existing 275/110 kV substation near Tandragee, Co. Armagh, to terminate at a new substation situated near Ballakelly Cross-roads in Co. Louth, about seven miles west of Dundalk, which will be constructed by the Electricity Supply Board.

The line will run from Tandragee substation directly to a point just east of Newtownhamilton passing the town of Tandragee to the west. From Newtownhamilton the line will continue practically

due south passing to the east of Cullyhanna and Crossmaglen and crossing the Border in the vicinity of Drummuckavall Townland.

2. At the existing Tandragee substation, the necessary switchgear and other equipment for the control, protection and monitoring of the 275 kV transmission circuits and such equipment as may be necessary for controlling and measuring the power flow over the new line.

*Number 2 Smoke Control Order—Braemere Heights—1967*

1. By virtue of Section 11 of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the occupier of that building be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, oil gas and electricity.
