- (b) The duties in respect of: Hydrocarbon oils Petrol substitutes Power Methylated spirits

(c) Purchase tax.

The surcharge is payable on amounts which be-come due on or after 6 p.m. on 22nd November 1968 in respect of the duties in group (b) above and on or after midnight on 22nd/23rd November 1968 in respect of duties in group (a) above and the pur-chase tax.

There is a corresponding 10 per cent. increase from the same date in respect of related drawbacks and similar rebates and allowances applicable to groups (a) and (b) above.

The Order comes into operation on 22nd Novem-ber 1968 and has been published as Statutory Instruments 1968, No. 1845.

# DEPARTMENT OF EMPLOYMENT AND PRODUCTIVITY

#### PRICES AND INCOMES ACT 1966

Reference to the National Board for Prices and

Incomes

#### PRODUCTIVITY AGREEMENTS

The White Paper on Productivity Prices and Incomes Policy in 1968 and 1969 (Cmnd. 3590), emphasises the continuing importance of encouraging increased productivity and efficiency and so helping to stabilise and reduce prices, and indicates that priority will continue to be given to increases which are justified under the productivity criterion. The Board's Report on Productivity Agreements (No. 36) contains a valuable interpretation of this criterion, and provides seven guidelines for the assessment of productivity agreements. Experience of the operation of the policy has, however, indicated that there are a number of special aspects of productivity bargaining which might usefully be explored further.

2. In pursuance of her powers under Section 2(1) of the Prices and Incomes Act 1966 the First Secretary of State and Secretary of State for employment and Productivity accordingly refers to the National Board for Prices and Incomes for examination the relationship of improvements in productivity to pay structures, the implications of productivity bargaining for costs, prices and profits, and the evaluation of productivity agreements with particular reference to:

٤.

- (i) the potentialities and problems of industrywide and company-wide productivity framework agreements,
- (ii) the application of productivity measurement and agreements to clerical and other nonmanual work,
- (iii) the potentialities and problems of partial agreements covering only certain workers or some issues, and
- (iv) the renewal and later development of existing agreements.

#### Reference to the National Board for Prices and Incomes of two settlements and a question relating to the pay of general workers and craftsmen employed by Imperial Chemical Industries Ltd.

Imperial Chemical Industries Ltd. has concluded wage settlements with Unions representing general workers and craftsmen employed by the Company which provide for increases in the basic rates of wages of these workers, an adjustment of the general workers' job appraisement rates and a revision of the tradesmen's grading bonus. In justification of these settlements, the Company has submitted evidence of increased productivity and a reduction in recent years of their price index.

The First Secretary of State and Secretary of State for Employment and Productivity acting in pursuance of her powers under section 2(1) of the Prices and Incomes Act 1966, hereby refers to the National Board for Prices and Incomes for their examination and report:

 the settlement reached on 31st October 1968 between Imperial Chemical Industries Ltd. on the one hand and the General and Municipal Workers' Union, the Transport and General Workers' Union, the Process and General Workers' Union and the Union of Salt, Chemical and Industrial and General Workers on the other providing, with effect from 25th November 1968, for:

- (a) an increase of 31d. per hour in the basic rates of wages of adult male and female general workers;
- (b) a specified percentage increase in the basic rates of wages of workers aged under 21 years; and
- (c) adjustment of job appraisement differentials;
- (2) the settlement reached on 4th November 1968 between Imperial Chemical Industries Ltd. on the one hand and the Amalgamated Engineering and Foundry Workers' Union; the Amalgamated Society of Boilermakers, Shipwrights, Blacksmiths and Structural Workers; the National Union of Sheet-metal Workers, Coppersmiths and Heating and Domestic Engineers; the United Pattern Makers Association; the National Union of Vehicle Builders; the Electrical, Electronic and Telecommunications Union, Plumbing Trade Union and the National Federation of Building Trades Operatives on the other providing, with effect from 25th November 1968, for
  - (a) an increase of 4d. per hour in the basic rate of wages for craftsmen;
  - (b) proportionate increases in the basic rates for other grades covered by the engineering workers' wages schedule and for for apprentices; and
  - (c) revision of tradesmen's grading bonuses; and
- (3) the question as to the likely effect of the settlements specified in (1) and (2) above on pay and conditions in the chemical industry as a whole.
