COMMISSION OF INQUIRY

Warrant of Appointment by the Governor of Northern Ireland

GREY OF NAUNTON

Whereas on and since 5th October 1968, sporadic outbreaks of violence and civil disturbance have occurred in Northern Ireland in consequence of the activities of certain bodies.

And Whereas it is desired to investigate the causes and circumstances thereof.

Now Therefore 1, Ralph Francis Alnwick, Baron Grey of Naunton, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Knight Commander of the Royal Victorian Order, Officer of the Most Excellent Order of the British Empire, Governor of Northern Ireland, reposing great trust and confidence in your knowledge and ability hereby authorise and appoint you

The Honourable Lord Cameron, D.S.C. (Chairman)

Professor Sir John Biggart, C.B.E.

James Joseph Campbell, Esq., M.A.

Commissioners to hold an enquiry into and to report upon the course of events leading to, and the immediate causes and nature of, the violence and civil disturbance in Northern Ireland on and since 5th October, 1968; and to assess the composition, conduct and aims of those bodies involved in the current agitation and in any incidents arising out of it:

And for the better effecting the purposes of this Commission I hereby grant unto you, or any of you, full power to call before you such persons as you shall judge likely to afford you any information upon the subject of this Commission; to call for information in writing; and also to call for, have access to and examine all such books, documents, registers and records as may afford you the fullest information on the subject, and to enquire of and concerning the premises by all other lawful ways and means whatsoever:

And I hereby authorise and empower you, or any of you, to visit and personally inspect such places as you may deem it expedient so to inspect for the more effectual carrying out of the purposes aforesaid:

And I hereby direct that this Commission shall continue in full force and virtue, and that you, or any of you, may from time to time proceed in the execution thereof, and of every matter and thing therein contained, although the same be not continued from time to time by adjournment:

And I further authorise you to report your proceedings uder this Commission from time to time if you shall judge it expedient so to do:

And I further request and desire that you shall, with as little delay as possible, report your opinion upon the matters herein submitted for your consideration.

The Ministry of Health and Social Services with the approval of the Minister of Agriculture, Fisheries and Food gives notice that in exercise of the powers conferred on it by the Imported Food (Northern Ireland) Regulations 1968 it hereby recognises, subject to the conditions hereinafter set out, each of the Official Certificates, of which particulars are given in the First Schedule hereto as showing:

- (a) that the meat to which they relate or the meat from which the meat product to which they relate was prepared, was derived from mammals inspected before and after death in the country of origin of the meat and passed in accordance with criteria satisfactory to the Ministry; and
- (b) that the dressing, packing and other preparation of the meat or meat product was carried out with all necessary precautions for the prevention of danger to health.

Where the Certificate is in the form of a label the recognition will apply only if the label is securely affixed to the meat or the package containing the meat or meat product and if the label has not in any other circumstances or on any other occasion been used as an Official Certificate; and where the Certificate is in the form of a stamp, the recognition will apply only if the stamp is clearly impressed or otherwise marked on the meat or the package containing the meat or meat product.


Recognition of the Official Certificates is extended to include meat described in the Second Schedule hereto.
