A PROCLAMATION

FOR APPOINTING MONDAY, JULY 12TH, 1926, A BANK HOLIDAY AND A PUBLIC HOLIDAY IN NORTHERN IRELAND.

WE, the Lords Justices of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland, in pursuance of the Bank Holidays Act, 1871, the Holidays Extension Act, 1875, and the Irish Free State (Consequential Provisions) Act, 1922, and of every power thereunto enabling, do hereby appoint Monday, the twelfth day of July next, as a special day to be observed as a Bank Holiday and as a Public Holiday in Northern Ireland under and in accordance with the said Acts, and we do by this Proclamation command the said day to be so observed and all loving subjects of His Majesty to order themselves accordingly.

Given at the Council Chamber, Stormont Castle, Belfast, this 6th day of May, in the year of our Lord One thousand nine hundred and twenty-six.

IN pursuance of the powers conferred upon us by The Wild Birds Protection Act, 1894, the Government of Ireland Act, 1920, and the several Statutes and Orders in that behalf, and upon application by the County Council of the County of Armagh, we do hereby make the following Order:—

The taking or destroying of the Eggs of the following species of Wild Birds is prohibited through out the Administrative County of Armagh between the 1st day of June, 1926, and the 1st day of August, 1926, and between the 1st day of March and the 1st day of August in the four subsequent years:—

Buzzard, Chough, Greenfinch, Great-crested Grebe, Harrier, Kingfisher, Peregrine-Falcon, Raven, Siskin, Skylark, Tern (all species), Gull (all species), Owl (all species), Lapwing (Peewit or Green Plover).

Buzzard, Chough, Greenfinch, Great-crested Grebe, Harrier, Kingfisher, Peregrine-Falcon,
