H.M. TREASURY

The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Section 5 of the Import Duties Act 1958.

Viz.: The Import Duty Reliefs Order, 1970.

This Order provides for the admission without payment of protective duty of certain goods imported for use or demonstration at exhibitions or other events held in the United Kingdom. It gives effect to the provisions affording relief from duty for such goods contained in the Customs Convention, dated 8th June, 1961, to which Her Majesty's Government in the United Kingdom is a party, concerning facilities for the importation of goods for display or use at exhibitions, fairs, meetings and similar events.

The Order comes into operation on 31st March, 1970, and has been published as Statutory Instrument 1970 No. 380.

BEE PEST PREVENTION ACTS

THE IMPORTED FOOD (NORTHERN IRELAND) REGULATIONS 1968

Spain: Official Certificate

The Ministry of Health and Social Services with the approval of the Minister of Agriculture, Fisheries and Food gives notice that in exercise of the powers conferred on it by the Imported Food (Northern Ireland) Regulations 1968 it hereby recognises, subject to the conditions hereinafter set out, the Official Certificate, of which particulars are given in the First Schedule hereto, as showing:

- (a) that the meat to which it relates, or the meat from which the meat product to which it relates was prepared, was derived from mammals inspected before and after death in the country of origin of the meat and passed in accordance with criteria satisfactory to the Ministry;

and

- (b) that the dressing, packing and other precautions of the meat or meat product was carried out with all necessary preparation for the prevention of danger to health.

The said Official Certificate is recognised subject to the following conditions:

- (i) This recognition applies only to meat and meat products imported from Spain but does not apply to any such meat or meat products derived from mammals killed when wild.
- (ii) Where the Certificate is in the form of a label, the recognition will apply only if the label is securely affixed to the meat or the package containing the meat or meat product and if the label has not in any other circumstances or on any other occasion been used as an Official Certificate; and where the Certificate is in the form of a stamp, the recognition will apply only if the stamp is clearly impressed or otherwise marked on the

meat or the package containing the meat or meat product.

- (iii) Recognition of the Official Certificate is restricted to the extent indicated in the Second Schedule hereto.
