The part of the watercourse to be dealt with under the Scheme flows 1,530 ft. downstream from the junction of Shantallow, Ballyarnet and Ballynagallagh townlands to the interstate border through or between the townlands of Ballynagallagh, Shantallow, Coshquin and Elagh More.

This Scheme replaces the Scheme published on 2nd May, 1969 and which was revoked on 5th May, 1970 in accordance with Section 6(c) of the Drainage Act (Northern Ireland) 1947 (Reprint to 1966).
