Now I The Rt. Hon. William Stephen Ian Whitelaw, M.C., D.L., M.P., Sccretary of State for Northern Ireland, in exercise of the powers vested in me in that behalf do by this Minute assign the powers and duties of the Ministry in connection with the registration of societies under the Friendly Societies Act (Northern Ireland) 1970, industrial and provident societies, trade unions and building societies to William Thomas McCrory, Esquire, to exercise and perform those powers and duties under the designation of Registrar of Friendly Societies for Northern Ireland, or, in relation to building societies for Northern Ireland, or, in relation to industrial assurance, under the designation of Industrial Assurance Commissioner for Northern Ireland in place of Ernest Simpson, Esquire, whose appointment in that behalf is hereby revoked. AID TO INDUSTRY
