Notice is hereby given that the Secretary of State in exercise of the powers conferred on him by section 23 of the Magistrates' Courts Act (Northern Ireland) 1964, on the recommendation of the Magistrates' Courts Rules Committee and after consultation with the Lord Chief Justice, has made a Statutory Rule entitled the Magistrates' Courts (Amendment) Rules (Northern Ireland) 1974 (S.R. 1974, No. 44).

These Rules amend the Magistrates' Courts Rules (Northern Ireland) 1965 to the following extent:

They provide for the procedure to be adopted after conviction of a person by a Magistrates' Court as to disclosure of that person's previous convictions.

There is provision to enable an affidavit of service of a summons notice, etc., to be sworn before the clerk of petty sessions.

They require a list of the dates on which an accused person is remanded to be sent to the court to which he is committed for trial.

Unless its court otherwise directs, a deposition need not include or solely relate to an application for the remand of the accused.

THE BELFAST—COLERAINE—LONDONDERRY TRUNK ROAD T7 (BALLYMONEY BY-PASS)

The proposed Order will also authorise the Department:

- I. to construct the following roads:
 - (a) a road in the townland of New Buildings South to connect the present trunk road to the southern side of the new road;
 - (b) two roads in the townland of Carnany Lower to connect the second class road B16 (Kilraughts Road) to the castern and western sides of the new road;
 - (c) two roads in the townlands of Drunkendult West and Townparks to connect the second class road B66 (Dervock Road) to the northern and southern sides of the new road;
 - (d) four roads in the townlands of Semicock and Ballycormick to connect the second class road B62 (Portrush Road) to the northern and southern sides of the new road;
 - (e) a road in the townlands of Ballywattick Middle and Moneygobbin to connect the present trunk road to the southern side of the new road;
- II. to stop-up wholly the following junctions:
 - (a) the junction at the eastern end of the new road in the townland of New Buildings South which will exist between the present trunk road and the southern side of the new road;
 - (b) the two junctions which will exist between the second class road B16 (Kilraughts Road) and the eastern and western sides of the new road;
 - (c) the two junctions which will exist between the second class road B66 (Dervock Road) and the northern and southern sides of the new road;
 - (d) the two junctions which will exist between the unclassified road D78X (Semicock Road) and the northern and southern sides of the new road;
 - (e) the junction at the western end of the new road in the townland of Ballywattick Middle which will exist between the present trunk road and the southern side of the new road;
- III. to construct the following bridges and approaches thereto:
 - (a) a bridge and approaches so that the second class road B147 (Newal Road) shall pass over the new road;
 - (b) a bridge and approaches so that the second class road B62 (Portrush Road) shall pass under the new road;
 - (c) a bridge and approaches so that the third class road C93 (Seacon Road) shall pass over the new road.
