

chains to and across the main road from Lisburn to Belfast thence in a south-easterly direction for 76 chains crossing Great Northern Railway and the Old Coach Road at Lambeg Parish Church also River Lagan to Sandy Lane thence in a southerly direction for 45 chains to and across Orr's Lane thence due south for 65 chains crossing Hillhall Road at Limetree House thence in a south-westerly direction to Clougher Road at Clogher School thence for 68 chains in a more westerly direction crossing the main Saintfield Road and Black Loaning Road to the main post road to Ballynahinch thence in a more westerly direction for 76 chains to the Hillsborough Old Road thence for 61 chains nearly due west to the main Hillsborough Road at Shamrock Ville.

5. To charge all the costs charges and expenses of and incidental to the preparation and obtaining of the Order to the Council.

6. Generally to confer all such further and other powers upon the Council as may be deemed necessary or expedient for effecting the purposes aforesaid.

Any local or other public authority, company or person desiring to make an objection to the draft Order may do so by letter addressed to the Department of Commerce at Chichester House, 64 Chichester Street, Belfast BT1 4JX despatched by recorded delivery service on or

before the 10th day of September, 1974. Any such objection shall state:

- (a) the specific grounds for objection; and
- (b) the modifications asked for.

A copy of the objection must be forwarded to the undersigned at the same time as it is sent to the Department.
