THE IMPORTED FOOD (NORTHERN IRELAND) REGULATIONS 1968

United States of America: Official Certificate

The Department of Health and Social Services with the approval of the Minister of Agriculture, Fisheries and Food gives notice that in exercise of the powers conferred on it by the Imported Food (Northern Ireland) Regulations 1968 it hereby recognises, subject to the conditions hereinafter set out, the Official Certificates of which particulars are given in the Schedule hereto as showing:

- (a) that the meat to which they relate or the meat from which the meat product to which they relate was prepared, was derived from manimals inspected before and after death in the country of origin of the meat and passed in accordance with criteria satisfactory to the Department and
- (b) that the dressing, packing and other preparation of the meat or the meat product was carried out with all necessary precautions for the prevention of danger to health.


The said Certificates are recognised subject to the following conditions:

- (i) Where the Official Certificates are in the form of labels, the recognition will apply only if the labels are securely affixed to the meat or the meat product or the package containing the meat or the meat product, and if the labels have not in any other
- circumstances conton any other occasion been used

- (ii) Where the Official Certificates are in the form of stamps, the recognition will apply only if the stamps are clearly impressed or otherwise marked on the meat or the meat product or the package containing the meat or the meat product.
- (iii) Recognition of the Official Certificate is restricted to those completed by the insertion of one of the establishment numbers currently approved by the Minister of Agriculture, Fisherics and Food.
