# A PROCLAMATION

FURTHER PROROGUING THE PRESENT PARLIAMENT OF NORTHEN IRELAND.

WHEREAS it is provided by the Government of Ireland Act, 1920, that the Lord Lieutenant shall, in His Majesty's name, summon, prorogue and dissolve the Parliament of Northern Ireland;

And Whereas the Parliament of Northern Ireland stands prorogued to Tuseday, the

21st day of February next:
NOW, I, The Right Honourable Edmund
Bernard, Viscount FitzAlan of Derwent, Lieutenant-General and General Governor of Ireland, by and with the advice of the Executive Committee of Northern Ireland, by this Proclamation do publish and declare His Majesty's Pleasure that the said Parliament be further prorogued to Tuesday, the 14th day of March next;

And I do hereby further, with the advice aforesaid, declare His Majesty's Royal Will and Pleasure to be that the said Parliament shall on the said Tuesday, the 14th day of March next, assemble and be holden for the despatch of divers urgent and important affairs, and the Senators and Members of the House of Commons of Northern Ireland are hereby required to give their attendance accordingly.

# PREVENTION OF DUMPING.

Rules of Procedure for Committees under PART II OF THE SAFEGUARDING OF IN-DUSTRIES ACT, 1921, (11 & 12 GEO. 5, C. 47), DATED FEBRUARY 6, 1922, PRESCRIBED BY THE BOARD OF TRADE IN PURSUANCE OF SECTION 7 (3) OF THE SAID ACT.

1. The Rules of Procedure for Committees under Part II of the Safeguarding of Industries Act, 1921, dated September, 23rd 1921 (S.R.O., 1921, No. 1514), prescribed by the Board of Trade in pursuance of Section

7 (3) of the said Act, are hereby revoked.
2. If the Board of Trade decide to refer any matter under Section 2 of the Safeguarding of Industries Act, 1921, to a Committee constituted in accordance with Section 7 of the Act, the Board will as soon as may be after the appointment of the Committee publish in the London, Edinburgh, Dublin and Belfast Gazettes, or in such other manner as the Board think proper, a notice stating-

- (a) the terms of reference to the Committee:
- (b) the time and place at which the Committee propose to hold their first sitting for the taking of evidence, which shall not be less than fourteen days after the date on which publication of the notice is completed.
- 3. The Board of Trade will appoint a Chairman of the Committee, who shall preside at any meeting of the Committee.

- 4. The sittings of the Committee at which evidence is taken shall be held in public, except that the Committee shall refuse to allow the public to be present at any proceedings of the Committee during the hearing of evidence on matters which, in their opinion, are of a confidential character.
- 5. The Committee shall be at liberty to take evidence in such manner as they shall think
- 6. Any person desiring to give evidence shall give notice to the Secretary of the Committee, and shall furnish, with his notice, a statement in writing of the evidence he pro-

poses to give.

7. The Committee shall be at liberty to decide whether they will or will not receive the evidence of any person who desires to give evidence, and their decision shall be final.

8. A witness whom the Committee desire to hear may, if he wishes, be accompanied by solicitor or counsel who may address the Committee on his behalf, but no witness shall be examined or cross-examined except by the Members of the Committee.

TRADE BOARDS ACTS, 1909 AND 1918.

LINEN AND COTTON HANDKERCHIEF AND HOUSE-HOLD GOODS AND LINEN PIECE GOODS TRADE BOARD (NORTHERN IRELAND).

The Trade Board established in Northern Ireland under the powers vested in the Ministry of Labour for Northern Ireland and in pursuance of Section 8 of the Government of Ireland Act, 1920, and the Enactments modified and adapted by the Government of Ireland (Adaptations of Enactments) (No. 3) Order, 1921, and any other Order of His Majesty in Council made under the said Act of 1920, for those branches of the Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods Trade specified in the Regulations of the said Ministry dated 2nd January, 1922, hereby give notice that they propose to fix minimum rates of wages for certain classes of male workers.

On request to the Trade Board, particulars of the minimum rates and information as to their application will be given if, in the opinion of the Trade Board, the applicant is

likely to be affected thereby.

The Trade Board will consider any objections to their proposals which may be lodged with them within two months from the 10th day of February, 1922. Such objections should be in writing and signed by the objector (adding his or her full name and address), and should be sent to the Secretary of the Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods Trade Board (Northern Ireland), Office of Trade Boards, Grand Central Hotel, Belfast.

It is desirable that persons making objections should state precisely, and so far as possible, with reasons, what is objected to.

TRADE BOARDS ACTS, 1909 AND 1918.

LINEN AND COTTON HANDKERCHIEF AND HOUSE-HOLD GOODS AND LINEN PIECE GOODS TRADE BOARD (NORTHERN IRELAND).

The Trade Board established in Ireland under and in pursuance of the Trade Boards Act, 1909, for certain branches of the Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods Trade having, as required by Regulations made by the Minister of Labour under Section 18 of the Trade Boards Act, 1909, dated 31st October, 1918, given due notice on the 15th day of August, 1921, of proposal to fix minimum rates of wages;

The Trade Board established in Northern Ireland under the powers vested in the Ministry of Labour for Northern Ireland in pursuance of Section 8 of the Government of Ireland Act, 1920, and the Enactments modified and adapted by the Government of Ireland (Adaptation of Enactments) (No. 3) Order, 1921, and any other Order of His Majesty in Council made under the said Act of 1920, for those branches of the Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods Trade specified in the Regulations of the said Ministry dated 2nd January, 1922, hereby given notice that they have varied certain minimum rates of wages.

The last-mentioned Trade Board have further given notice that they have received notification that an Order was made by the Ministry of Labour for Northern Ireland on the 1st day of February, 1922, under Section 4 (2) of the Trade Boards Act, 1918, confirming the minimum rates as fixed by the Trade Board as aforesaid, and specifying the 13th day of February, 1922, as the date from which such minimum rates of wages should effective.

On request to the Trade Board, particulars of the minimum rates and information as to their application will be given if, in the opinion of the Trade Board, the applicant is likely to be affected thereby.

## GOVERNMENT OF NORTHERN IRELAND.

#### MINISTRY OF COMMERCE.

WHEREAS, in pursuance of the Government of Ireland Act, 1920, the Ministry of Commerce for Northern Ireland has been directed to administer in Northern Ireland as from the first day of January, 1922, Irish Services in connection with the matters specified in the several Parts of the Appendix to this Minute; and the functions before that day discharged by certain Departments and officers of the Government of the United Kingdom in relation to those matters are as from that day, in so far as they relate to Irish Services in Northern Ireland, transferred to the

Ministry of Commerce.

And Whereas, under sub-section (3) of Section 1 of the Ministries of Northern Ireland Act, 1921, (N.T.) the Minister of Commerce may, if he thinks fit, by Minute to be laid before both Houses of Parliament, assign any specified powers or duties of the Ministry of Commerce to such officers as he may appoint to exercise or perform the same under any designation having reference to such powers or duties.

Now, I, The Right Honourable Edward Mervyn Archdale, Minister of Commerce, do by this Minute:

- (1) Assign the powers and duties of the Ministry in connection with the registration of the subjects specified in Part 1 of the Appendix to Mr. Cecil Litchfield, of the Ministry of Commerce, and appoint—
  - (a) Mr. Cecil Litchfield to exercise and perform those powers and duties under the designation of Registrar of Friendly Societies for Northern Ireland;
  - (b) Mr. Walter Abbott, of the Ministry of Commerce, to assist Mr. Litchfield in such exercise and performance under the designation of Assistant Registrac of Friendly Societies for Northern Ireland.
- (2) Assign the powers and duties of the Ministry in connection with the registration of the subjects specified in Part II of the Appendix to Mr. Walter Abbott, of the Ministry of Commerce, and appoint—
  - (a) Mr. Walter Abbott to exercise and perform those powers and duties under the designation of Registrar of Joint Stock Companies for Northern Ireland;
  - (b) Mr. James Stewart, of the Ministry of Commerce, to assist Mr. Abbott in such exercise and performance under the designation of Assistant Registrar of Joint Stock Companies for Northern Ireland.
- (3) Assign the powers and duties of the Ministry in connection with the registration of the subjects specified in Part III of the Appendix to Mr. Walter Abbott, of the Ministry of Commerce, and appoint—
  - (a) Mr. Walter Abbott to exercise and perform those powers and duties under the designation of Registrar of Business Names for Northern Ireland;
  - (b) Mr. James Stewart, of the Ministry of Commerce, to assist Mr. Abbott in such exercise and performance under the designation of Assistant Registrar of Business Names for Northern Ireland.
- (4) Assign the powers and duties of the Ministry in connection with the registration of the subjects specified in Part IV of the Appendix to Mr. Walter Abbott, of the Ministry of Commerce, and appoint—
  - (a) Mr. Walter Abbott to exercise and perform those powers and duties under the designation of Registrar of Money Lenders for Northern Ireland;
  - (b) Mr. James Stewart, of the Ministry of Commerce, to assist Mr. Abbott in such exercise and performance under the designation of Assistant Registrar of Money Lenders for Northern Ireland.
