#### COUNTER-INFLATION ACT 1973

"Paragraph 103 of Schedule 1 to the Counter-Inflation (Price Code) Order 1976—SI 1976 No. 1170—permits departures from the provisions of the Price Code at the discretion of the Secretary of State in relation to any product or commodity where a serious threat of a severe shortage of supplies in the domestic market, threatening significant damage to the interests of particular industries in the United Kingdom, is certified. The following certificate has been issued under this paragraph amending an existing certificate which permits departures from the provisions of the Price Code in relation to indigo dye:"

Certificate of the Secretary of State for Prices and Consumer Protection under paragraph 103 of the Price Code set out in Schedule 1 to the Counter-Inflation (Price Code) Order 1976

The Secretary of State for Prices and Consumer Protection, having regard to the need to alleviate a serious threat of a severe shortage of supplies in the domestic market, hereby certifies in relation to indigo dye that:

- (a) there is such a threat; and
- (b) significant damage is thereby threatened to the interests of particular industries in the United Kingdom;

and specifies in relation to increases in prices of indigo dye implemented while this Certificate is in force that the departures from the provisions of the Code relating to allowable cost increases, increases in total costs and net profit margins set out in the Schedule to the Certificate given by him on 14th January, 1976 (having effect under Article 3(3) of the Counter-Inflation (Price Code) Order 1976 as if given under paragraph 103 of the Code set out in Schedule 1 to that Order) shall be permitted by the Price Commission as if, in paragraph 1 of the Schedule to that Certificate, for "125%" there were substituted "185%".

The said Certificate given on 14th January, 1976 as varied by this Certificate shall have effect as so varied until further varied or revoked.
