### UNEMPLOYMENT INSURANCE ACTS (NORTHERN IRELAND), 1920 to 1928.

The Ministry of Labour for Northern Ireland hereby gives Notice in accordance with the provisions of the Unemployment Insurance Acts (Northern Ireland), 1920 to 1928, that it is proposed to make a Special Order varying and amending the provisions of the Insurance Industry Unemployment Insurance Scheme (Northern Ireland), 1926, being a special scheme for the insurance against unemployment of persons employed in the Insurance Industry.

Copies of the draft order may be obtained on application to the Secretary of the Ministry of Labour, Ormeau Avenue, Belfast, to whom any objections made with respect to the draft order by or on behalf of persons affected must be sent within twenty-one days of the date of

this notice. Every objection must be in writing, and must state:—

- (a) the draft order or portions of draft order objected to;
- (b) the specific grounds of objection, and
- (c) the omissions, additions, or modifications asked for.
