WHEREAS by section sixty-nine of the Government of Ireland Act, 1920, His Majesty is empowered by Order in Council to make such regulations as seem necessary or proper for setting in motion the Parliaments and Governments of Southern and Northern Ireland, and also for any other matter for which it seems to His Majesty necessary or proper to make provision for the purpose of bringing the said Act into full operation or for giving full effect to any of the provisions of the said Act, and in particular His Majesty is empowered amongst other things, by any such Order in Council to make such adaptations of any enactments as far as they relate to Ireland as may appear to Him necessary or proper in order to give effect to the provisions of the said Act:

And whereas for the purposes of the provisions of the said Act relating to the transfer of services, the twenty-second day of November, nineteen hundred and twenty-one, was fixed as the appointed day as respects Northern Ireland in relation to the financial provisions of the said Act, including taxation, but no day has as yet been fixed for the purposes aforesaid as respects Southern Ireland:

And whereas by the Government of Ireland (Adaptation of Taxing Acts) Order, 1922, provision has been made (among other matters) with respect to the application to Northern Ireland of the enactments relating to death duties:

And whereas it is necessary on account of the urgency of the matters dealt with by this Order that this Order should come into operation forthwith:

1.--(1) This Order may be cited as the Government of Ireland (Adaptation of the Taxing Acts) (No. 2) Order, 1922, and shall come into operation provisionally as from the date hereof in accordance with the provisions of section two of the Rules Publication Act, 1893.

(2) The Interpretation Act, 1889, applies to the interpretation of this Order in like manner as it applies to the interpretation of an Act of Parliament.

2. The Government of Ireland (Adaptation of Taxing Acts) Order, 1922, shall have effect as though the following Article were inserted therein after Article 14 thereof—

"14A. The power of the Ministry of Finance for Northern Ireland to make regulations under section thirty-four of the Finance Act, 1917, as that section applies to Northern Ireland, shall be exercisable by the Ministry subject to the approval of the Treasury."

WHEREAS by section sixty-nine of the Government of Ireland Act, 1920 (hereinafter referred to as "the Act"), His Majesty is empowered by Orders in Council (therein referred to as "Irish Transfer Orders") to make such regulations as seem necessary or proper for setting in motion the Parliaments and Governments of Southern and Northern Ireland, and also for any other matter for which it seems to His Majesty necessary or proper to make provision for the purpose of bringing the Act into full operation or for giving full effect to any of the provisions of the Act:

And whereas it is provided by subsection (3) of section thirty-two of the Act that it shall be the duty of the Joint Exchequer Board to determine any matter which is to be determined by the Board in pursuance of any Irish Transfer Order made under the Act:

And whereas for the purposes of the financial provisions of the Act the twenty-second day of November, 1921, has been fixed as the appointed day as respects Northern Ireland, and for the purposes of the provisions of the Act relating to the transfer of services the twenty-second day of November, 1921, the first day of December, 1921 the first day of January, 1922, the first day of February, 1922 and the first day of March, 1922, have respectively been fixed by Orders in Council dated the ninth day of November, 1921, and the twenty-second day of December, 1921, respectively, as the appointed days as respects Northern Ireland in relation to the several Irish services mentioned in the said Orders respectively, but no day has yet been fixed for the purposes aforesaid as respects Southern Ireland.

And whereas the provisions of section 1 of the Rules Publication Act, 1893, have been complied with:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council to order, and it is hereby ordered as follows:---

1.—(1) This Order may be cited as the Government of Ireland (Adjustment of Payments) Order, 1922.

(2) The Interpretation Act, 1889, applies for the purposes of the interpretation of this Order in like manner as it applies to the interpretation of an Act of Parliament.

2. The Joint Exchequer Board shall, at the request of the Treasury, determine any question that may arise—

- (a) as to the extent to which any charge on the Consolidated Fund of the United Kingdom for Irish services, including any charge for the benefit of the Local Taxation (Ireland) Account. or any grant or contribution out of moneys provided by the Parliament of the United Kingdom, so far as made for those services, ought to abate:
- (b) as to the extent to which any payment to be made directly or indirectly out of the Local Taxation (Ireland) Account for Irish services ought to be reduced

by reason of the coming into operation of the financial provisions of the Act as respects Northern Ireland and the transfer of Irish services to the Government of Northern Ireland; and in making such determination the Board shall endeavour to secure that the charge, grant, contribution or payment shall, pending the coming into operation of the financial provisions of the Act as respects Southern Ireland and the transfer of Irish services to the Government of Southern Ireland. continue at a rate or amount sufficient to enable the like payments to be made thereout for purposes in Southern Ireland as would have been made if the Act had not passed.
