### CONSUMER CREDIT ACT 1974

General Notice Number 22

On 8th May 1980 the Director General of Fair Trading issued General Notice Number 22 pursuant to Section 6(2) of the Consumer Credit Act 1974.

General Notice Number 22 supersedes General Notices Numbers 9, 10 and 13 and consequently Forms CC5/75, CC7/75 and CC6B/75 are no longer to be used.

### THE CLEAN AIR ACT (NORTHERN IRELAND) 1964

The Belfast (No. 17) Smoke Control Order (Northern Ireland) 1980

- 1. Notice is hereby given that the Belfast City Council, in exercise of the powers conferred on them by Section 11 of the above-mentioned Act, on the 1st day of May, 1980, made an Order entitled the Belfast (No. 17) Smoke Control Order (Northern Ireland) 1980, declaring the area described in the schedule hereto to be a smoke control area, which Order is about to be submitted to the Department of the Environment for confirmation.
- 2. Subject to the exemptions provided by virtue of Sections 11 and 18 of the Act, if on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £20 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.
- 3. Copies of the Order and of the map referred to therein may be inspected free of charge at the Environmental Health Department, City Hall, Belfast, until 4th July, 1980.
- 4. Within the said period any person who will be affected by the Order may by notice in writing to the Secretary, Department of the Environment, Stormont, Belfast BT4 3SS, object to the confirmation of the Order.
