THE EUROCONTROL (IMMUNITIES AND PRIVILEGES) (AMENDMENT) ORDER 1980 (SI 1980 No 1076)

This Order came into operation on 1st January 1981, the date on which the Protocol for the Amendment of the Additional Protocol to the 'Eurocontrol' International Convention relating to Co-operation for the Safety of Air Navigation (Cmnd 7477) entered into force in respect of the United Kingdom.

NORTHERN IRELAND COURT SERVICE

Notice is hereby given that the Lord Chancellor, in pursuance of section 117(1) of the Judgments (Enforcement) Act (Northern Ireland) 1969, has made a Statutory Rule entitled the Judgment Enforcement (Amendment) Rules 1981. (SR 1981 No 21). These Rules which come into operation on 2nd March 1981 amend the Judgment Enforcement Rules 1979 by substituting a new scale of costs in enforcement proceedings.

Rule 103(5) is amended to provide that when the amount due on foot of a judgment does not exceed £100 no solicitors' charges shall be allowed. Rule 103(7) is amended by

the substitution of a new paragraph which provides that where, because of the weight or difficulty of a case, the Master (Enforcement of Judgments) considers the fee prescribed in respect of the preparation for an attendance at certain hearings to be insufficient, he may increase that fee to an amount not exceeding £15.
